I remain very grateful for the opportunity to serve Alcoholics Anonymous in this capacity. During our Assembly, a motion was made to update the Georgia Alcoholics Anonymous history book, We Share. It was tabled and an ad hoc committee will be appointed to study the costs and logistics of updating the book. A report will be presented at the January Assembly. It is prudent for us to be very thoughtful about undertaking such a large and important initiative. We also talked about our Spanish speaking trusted servants and our need to improve communication with District 17 (Spanish linguistic District). We have another ad hoc committee looking at this need. Both of these topics are included in this

Message's Assembly minutes. Considering Concepts XI and XII, I am always impressed with our Area's Group conscience on matters of importance and the guidelines developed by those that came before us. We practice the spirit of both of these Concepts on a regular basis. Concept XI includes principles such as fairly compensating our paid workers, rotation and participation. We do have a paid worker as our Office Manager for the Area Office. We make sure that the position is paid fairly for the skills required and the responsibilities it includes. Concept XII includes the General Warranties of the Conference. The first sentence states "the Conference shall observe the spirit of the AA Tradition". This also applies to our Area. The Warranties include principles that apply to our Area as well. Refer to the Concept Checklist excerpt below to address questions that will lead to a better understanding of these two Concepts. Concept XI: The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

- How do we encourage our special paid workers to exercise their traditional "Right of Participation?"
- Do we practice rotation in all our service positions?

Concept XII: The Conference shall observe the spirit of AA tradition, taking care that it never becomes the seat of perilous wealth or power, that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all

important decisions by discussion, vote, and, whenever possible, by substantial unanimity: that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

Corrections correspondence very gratifying form of Twelfth Step work.

Perhaps one of the most rewarding and rarely mentioned forms of Twelfth Step work is our Corrections Correspondence Service (CCS). This is a program that is coordinated by the General Service Office to allow outside AA members to correspond with our fellow alcoholics who are incarcerated and have no other way to find sobriety. Those who have participated in this program have found sharing with inmates to be a The process begins when an inmate somewhere in the U.S. or Canada writes to the General Service Office and requests to correspond with an outside AA member. GSO then matches up inmates with our volunteers by sending the inmates' contact information to the outside AA. Next, the AA volunteer contacts

the inmate by mail, usually starting with an introductory letter. Something to remember is that men correspond with men and women correspond with women. The outside AA member must use his or her full name on all correspondence because it is a require-

ment of most correctional facilities. Most correspondents use their home address since GSO matches them up with inmates who are located in different regions, however some choose to use their group or District/Zone P.O. Box.

We urge you to obtain a copy of the pamphlet "Corrections Correspondence – a special kind of AA Service" (F-26) which is available at local meetings and on our website, aageorgia. org. Please consider filling one out today. We hope everyone has a very happy and safe holiday season, and we look forward to seeing you at the Georgia State Service Assembly in January.

ASSEMBLY MINUTES

(Area 16) Assembly Weekend

Marriott Macon City Center, Macon, Sept. 18, 2011

David M., Area 16 Chairperson, opened the business session of the Area 16 Service Assembly with the Serenity Prayer. The meeting was opened at 9:05 a.m.

Delegate Report - Patty L.

Good morning. My name is Patty L. and I am an alcoholic. Thank you all for being here this morning. I would like to welcome our guests – Julio E., GSO Staff and Jennifer D., Panel 61 Delegate from North Carolina.

Our September Assemblies are important for us as we elect our Area trusted servants. Selecting good leaders helps us to ensure the future of Alcoholics Anonymous. Concept IX says, "Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety." We in Area 16, Georgia have sound and appropriate methods for choosing our leaders as outlined in our Service Manual. As always, we have a great group of willing service leaders that have made themselves available. Thank you Tom, Teri, Brett, Dan, Rebecca, Art, and Chuck for your willingness to serve.

This weekend you will receive the Final Report of the 61st General Service Conference. I encourage you to read it and share it with your group. The report I gave in May was just a summary of the Conference. For example, the Conference voted that the General Service Conference take an inventory. I included that in my report, but on pages 11-13 in the final report there is a description of how the inventory will be conducted and the inventory questions. The Final Report also includes:

- Reports from the Boards, Trustees Committees, and GSO and Grapevine Staffs,
- The workshop presentations on our Conference theme by the Delegates,
- Recommendations and floor actions not resulting in Advisory Actions
- Financial reports and much more (make note of Area 16 Georgia's rank

in contributions from the US for 2010 - #1).

An interesting fact about the illustrations is that they are actual drawings from the Conference. The illustrator was there drawing while the Conference was in session.

The General Service Board is scheduled to conduct an inventory of itself in October. El, our Southeast Trustee, serves on the planning committee for this inventory process. The Conference inventory will begin in 2013, and span three conferences. In addition, the Grapevine Board will be evaluating its Board composition and size. It nice to see our Conference and Boards using the same tools we use in our Area, Districts and Groups as well as our own personal recovery. To me, that is a sign of a healthy organization.

GSO staff rotates staff assignments every two years. This July, the staff moved to their new assignments. If you call for a specific desk (eg. Pl, Corrections, etc), the phone numbers have not changed, and neither has the email. However, you will get the new person in that role. I will put the new assignments on our website. Our new Southeast correspondence person is Gayle S.; all calls, letters and emails from the Southeast will be forwarded to Gayle.

As a result of the last Conference, we now have a pamphlet," AA for the Alcoholic with Special Needs", an updated version of "AA Member - Medications and Other Drugs", and updated version of "Understanding Anonymity." These pamphlets are all available to order. Our eBook version of the 4th edition Big Book and the Twelve and Twelve will be available this November - check on www.aa.org for the status. The AA Membership Survey was conducted in August. GSO should receive the completed surveys back by early September. We had 9 groups included in the survey.

The Grapevine continues to have financial challenges. The monthly reports from the Grapevine and LaVina are asking for support through subscriptions and purchasing products. A new catalogue is available on line with limited paper copies to send out by request. In addition, the Grapevine products are now included in the AA World Service's catalogue. Two new books were published this year. Emotional Sobriety II and Step by Step. Both are compilations of stories from the magazine. Check out the new website for web exclusives, daily stories, audio files and archives. Some of you may have noticed that Facebook and

Twitter were linked to the Grapevine's website for a short period of time. From what I understand the Board was told by the staff that they were going to use Facebook and Twitter to increase engagement with the readership. The Board approved it without a full understanding of the consequences. When it was brought to the attention of members in several areas, it was quickly escalated to the Grapevine Board due to issues with Anonymity. The Board voted to have it removed immediately. It has been recommended to the General Service Board that a study be undertaken to address alignment and utilization of social networking with the Steps, Traditions and Concepts.

Several of the Trustees Committees have asked for sharing from the Fellowship. Archives would like experiences with successes in archives collections. These experiences will be added to the Archives Workbook in the "Archives Committee Activities - Shared Experiences "section. The Corrections Committee will request sharing on new challenges and solutions in 12th Step work in Correctional Facilities. Finally, the Finance Committee is still requesting stories that humanize our 7th Tradition. I know that we have experiences to share from Georgia. Please take the time to write up anything you may be doing that others could learn from.

We had our Southeastern Conference in August. It was a great event hosted by North Carolina in the beautiful city of Raleigh. We have talked about the motion by the Southeastern Conference to add a service assembly to the Southeast Region bi-annually. Following the vote, an ad hoc committee was selected to draft guidelines for the service assembly. The Delegates provided feedback on the guidelines and they were presented at the Southeastern Conference in August for a vote. The guidelines were not adopted. In the meantime, Virginia decided to proceed with a service assembly, and a few other Areas joined in to support the event. It is called the Southern States Alcoholics Anonymous Service Assembly, and will be held November 4-6, 2011 in Fairfax, VA. The event is modeled after the Service Assembly in the Northeast Region. I have flyers if anyone is interested in attending.

If you have received your Box 459 Falt edition, you have seen the full page article about the 2015 International Convention in Atlanta. The International Convention Committee is accepting ideas for the Convention theme. The article includes past themes and a mailing address to send your ideas

in. Registration and housing information will be sent out to all registered Groups in September 2014. Box 459 and www.aa.org will have updates on the International as more information is available.

I received an email from one of our members sharing about a Daily Reflection website that was told to cease posting and emailing excerpts from our book Daily Reflections. There was an update about this in my recent communication from GSO. "AAWS recently requested an unauthorized source to stop posting Daily Reflections online without permission and to refrain from emailing daily excerpts to subscribers because this infringed on the copyright of this book, and they have complied" (quoted from "Highlights from AAWS", July 2011). GSO received about 800 emails and phone calls complaining about his action. In these complaints there were suggestions that GSO should provide this service. It is being considered.

In addition to our elections this weekend, we have several other exciting topics being discussed. We have considered a redistricting proposal between Districts 11A and 16B. According to our Manual, redistricting requests are first reviewed by the Office Committee, voted on by the DCMs and if approved brought to the GSRs. That process took place on Friday night and Saturday. It will be brought to the GSRs today. The Office Committee had a preview of our new web site design that is scheduled to be published during our PrePaid Convention in October. The Web Committee and their helpers have done a great job with the design and transferring the English and Spanish content to the new site. It has been a lot of work. The DCMs received the 2012 Budget for Area 16. You all will have an opportunity to see that prior to approval by the DCMs at our November DCM Planning Meeting. Finally, I have appointed an ad hoc committee to address our need for Spanish translation of our DCM and GSR meetings and workshops as well as all of our written material. District 17 has been a part of Area 16 Georgia for several years now and we have fallen short of being inclusive for our Spanish speaking trusted servants. The goal of the committee, chaired by John L., District 8 DCM, will be to have a recommendation for the DCM Planning Meeting in November.

In May, my report to you was primarily from the 61st General Service Conference. For those of you that were here, I left something out. I left out my two-minute farewell message to the

Conference. Most of the second year Delegates, **more than 40, took two** minutes to address the conference at the end. It is a very moving experience. I saved mine because I wanted to use the same sentiment when saying farewell to this body as your Delegate. This is my last Assembly as Delegate. Only a handful in this room, know what it is like to see how Alcoholics Anonymous works from the top (groups) to the bottom (GSB), and to meet people from all over the world who love AA just as much as each of us. I am grateful to you for that experience. I am a better person for having served as your Delegate. I have continued friendships and made many new friends. I am amazed by the quality of sobriety and character of all of the trusted servants I have worked with, especially our past Delegates, Office Committee, and all of you. I have gained wisdom, hope and a sense of peace regarding the future of our Fellowship. In each phase of my service work, I have experienced all of these things even before I was elected Delegate. I came to the Georgia State Service Assembly 23 years ago and had the exact same experience with people from all over Georgia. And there are many more than a handful of you, like I, that have enlarged your spiritual life by participating in service work. I look forward to being the Assembly Chairperson, and to continue as a part of our Office Committee. Thank you all for your support and encouragement. Especially my husband Rusty, who has provided continuous encouragement, traveled with me all over and sometimes just quietly stepped aside.

As I contemplate my next service position, I realize how much I will miss David S., as he will be rotating back to his home group. Thank you, David for all the time and energy you have given to our Fellowship.

to update and correct group information, and to please have done for the DCMs to bring to the November 12th DCM Planning meeting in Macon. Instruction letters were given to the DCMs for information needed to update both here in Area 16 and GSO-New York. Tamera now has the ability to make any changes directly online with GSO. Remember that our 2012 Area Directory will be updated from the information you provide. Any group that becomes inactive or changes to meeting only status will no longer be printed in the Area Directory. Remember the Central Offices and Intergroup Offices are a separate entity, and are not required to (and generally don't) provide any information to the Area Office - it is the group's responsibility to keep our Area Office informed of any group changes.

Treasurer Report - Don M.

Good news is that group contributions to GSSA are up two percent (+2%) through the end of August. However, group contributions to the prepaid convention are down seventeen percent (-17%) for the same time frame. Of the 752 groups in Area 16 (State of GA), 57% contributed to GSSA and 42% contributed to the prepaid convention. Don recognized Districts 9 & 11B for 100% contribution to GSSA, and Districts 5A & 5C for 100% contributions to both GSSA and the pre-paid convention. The cost per individual for this Assembly is \$20.74, and with that Don read the "Green Card" and the baskets were passed.

Alternate Delegate Report - Tom H. We have one Cluster Forum remaining this year on November 5th in Metro Atlanta. The DCMs will begin receiving the Area Function lists with each message mailing and it will be available at the registration desk.
