The Area will also receive the ad-hoc committee report to move all related expenses to the Prepaid Convention currently being paid by the GSSA account to the pre-paid account.

I would like to take this opportunity to welcome our new Area 16 Webmaster – Jonathan W. Make him feel welcome at our Assembly. Also, Diane M. will be

presented for your approval as our new Communications Committee Co-Chair. Thank you both for stepping up to fill two of our most important vacancies.

Area 16 along with Area I (Alabama), will be hosting the SSAASA IV (Southern States A. A. Service Assembly) in Atlanta, November 2017. Rebecca T., our **Assembly** Chairperson will be our Area representative on that committee and I know we will have a lot of volunteers to help her as the time nears. Also, remember that at the May Assembly we will be receiving nominations for the new Delegate to be elected in September for the year 2018/2019 (Panel 68). Participation: Leadership- "I am Responsible"

I'm currently involved in my home group-sponsored Concept Study, and while studying Concept IX, I read Bill's included essay on "Leadership in AA: Ever a Vital Need". I believe the entire essay is a great example of this year's Participation theme and sub-topic - Leadership). Due to a recent personal experience, I was particularly reflective on the following passages at the very end of his essay:

"While this article was first thought of in connection with our world service leadership, it is possible that some of its suggestions can be useful to anyone who takes an active part in our Society.

This is true particularly in the area of Twelfth Step work, in which nearly all of us are actively engaged. Every sponsor is necessarily a leader. The stakes are about as big as they could be. A human life and usually the happiness of a whole family hang in the balance. What the sponsor does and says, how well he estimates the reactions of his prospects, how well he

times and makes his presentation, how well he handles criticisms, and how well he leads his prospect on by personal spiritual example—these qualities of leadership can make all the difference, often the difference between life and death.

We thank God that Alcoholics Anonymous is blessed with so much leadership in all of its affairs."

These **essay** statements "rang true" to me recently, as my family suffered the loss of a member to the effects of alcoholism. During this sad time, my sponsor took time out of his schedule and fulfilled a "responsibility" by calling with his condolences, support, and spiritual experience. Even though I was surrounded by loving family members, his call was perhaps my most comforting message during this sorrowful time; to me, my sponsor demonstrated true Leadership and Responsibility. "Every sponsor is necessarily a leader." "What the sponsor says and does..." I continue to feel so grateful to A.A. and its leaders for these blessed examples in my life today - "taking an active part in our society".

you for your efforts!!

Additionally, the Augusta Pre-paid Convention was a great success, coming in under budget. Archives Committee Report

The District 17 Spanish Metro Atlanta Cluster Forum was held at the Grupo Sobriedad Latina Clubhouse in Doraville, Georgia on March 17. A presentation was made on the history of the Spanish edition of *Alcoholics Anonymous*.

The first translation may have been made in Cleveland and sent to the New York headquarters. However, that version was lost. A translation was made in New York City, but the knowledge of how this translation arrived in any Spanish speaking country is not clear. We know that four main Spanish versions evolved in this hemisphere. The four versions were from Mexico, El Salvador, Columbia and Puerto Rico. The Puerto Rican translation was reprinted by the GSO by April of 1955.

A fifth version evolved by 1962 translated into Castilian Spanish which became used in Spain.

But none of these versions were formally validated by the GSO. The translations varied depending on the local dialect. The contents of the translations sometimes seemed to leave certain ideas behind.

The GSO eventually hired a Spanish Services coordinator who expressed much concern about the shortcomings of the **printed** version. A new translation was made and this First Spanish Edition was published in 1986. However, this version ended with Dr. Bob's Story. No Spanish version to date had included stories similar to the American editions.

By 1990, a Second Edition was published that included 12 Spanish original stories along with two translated American stories "Alcoholics Anonymous Number Three" and "Women Suffer Too."

A Third Spanish Edition was published in 2008 that included 32 new Spanish stories. This Edition was the first that approximated the size and weight of an American Big Book.

I can speak first hand to the powerful reaction of an inmate who reaches out to AA when given the smallest gift: a Grapevine, a letter of encouragement, or even a Big Book. In my experience, these members of AA desperately want what we have, and are willing to go to any length to get it. Serving those behind the walls who want our way of life has been one of the most rewarding, humbling experiences in my recovery.

If you would like to have a humbling experience by reaching out to some of these inmates, there are several ways to help. First, volunteers are always needed to respond to the "Bridge the Gap" pamphlets we receive. Literature, correspondence, and even sponsorship through the mail are an incredible gift. The most rewarding experience in my view also comes with the biggest commitment; to carry the message of AA behind the walls of a state prison.

To carry the message behind the wall, you first must be trained. The next training session will be Saturday, May 27th from 8:00 a.m. to noon at the State Office in Macon. Upon successful completion of the training and

approval by the State of Georgia, you will need to contact one of the three Regional Offices closest to you to make an appointment to get your badge. This is done the third Saturday of each month, and you **MUST** call the Friday before by noon to confirm your appointment.

Finally, there will be two Corrections Workshops during the Georgia State Service Assembly. The first will be at 11 a.m. and the evening workshop will take place at 9:30 p.m. We look forward to seeing you all there, and are always
