Our Purpose


Gather feedback on the recommendations made by the Communications Audit Report:

Be more effective in attracting and retaining those in need of recovery, the Professional Community, AA Members and improve public perception.

AA perceived as religious?

- Yes, but it is softened by the fellowship once you come in and work the steps.
- Public does not perceive AA as religious.
- Not concerned with public perception.
- Strengthen Communications Committee?
- Our message of recovery is consistent in Area 16.
- Update our website.
- Work with courts to explain our Primary Purpose.

Strengthen and unify our messaging

How can we utilize GV Committee to encourage members to share stories?

- GV is great!
- Announce at meetings that stories are needed for the GV.
- Have workshops or develop pamphlets/guidelines on how to submit stories to the GV.

Do we need more speaker meetings?

- Overwhelming majority said, "Yes".
- Help get non-religious message out.
- Get meeting tapes made.

Leverage our history to become more impactful communicators

Relate more to someone telling about something or sharing personal experience?

- Overwhelming majority-Personal Experience
- Include all parts-what we were like, what happened, and what we're like now.
- Big Book includes stories and BB studies are great!

How can our Archives Committee provide additional platforms to share our AA History?

- No additional platforms needed.
- More digital materials need to be made available.
- Tie: Archives need to be saved before they deteriorate; and, better communication from archives.

Provide guidance in the use of social media and other interactive tools to more deeply engage the fellowship

Benefits and pitfalls of social media?

- It's a tie!
 - Against social media.
 - Need to safeguard our anonymity.
- It's essential to the newcomer.

What if we "opt out" of social media?

- We will lose a generation of people who need the message.
