Happy New Year and welcome to 2023 in Area 16. We have another year of fulfilling our primary purpose, carrying the message to the still suffering alcoholic. Alcoholics Anonymous in Area 16 holds many different events throughout the year to help carry the message of AA. There are service Assemblies, cluster forums, workshops, conventions, Roundups, and virtual presentations.

Here are some highlights of upcoming events. Many of them have not confirmed their dates yet, and there will be additional ones popping up later in the year. The Georgia State Service Assembly office in Macon and the Alternate Delegate maintain an ongoing Area 16 Functions List for the year. This list contains any upcoming AA event in the state of Georgia as well as some around the U.S. and Canada. Area 16 holds a service Assembly weekend in Dublin, Georgia, during the months of January, May, and September. There are workshops focused on committees and trusted servant on Saturday, a speaker meeting Saturday night, and the business meeting on Sunday morning. It is during the business meeting when GSRs vote on motions affecting AA in Area 16 and elections of our area trusted servants.

There are four cluster forums scheduled during the year: Southeast Cluster Forum (March 25, St. Simons), East Central Cluster Forum (June), Northwest Cluster Forum (August), and District 17 Cluster Forum (November, Atlanta). Each cluster forum focuses and presents on the theme for that year. The theme for 2023 voted on by the GSRs is "AA's Three Legacies – Our Common Solution". Other presentations include re-

ports from some of the Area officers and each area committee chairperson.

There are several conventions planned: 70<sup>th</sup> Prepaid Convention (October 20-22, Augusta) and the 45<sup>th</sup> Al-Anon/Alateen Convention (August 4-6, Helen). Several roundups are available to attend: 26<sup>th</sup> Flint River Roundup (March 10-12, Albany), 29<sup>th</sup> Marietta Spring Roundup (May, Marietta), 46<sup>th</sup> Atlanta Roundup (Atlanta area), and the 44<sup>th</sup> Allatoona Roundup (August 18-20, Cartersville).

Look out for many virtual presentations organized by some of our area committees as well as workshops put on by Districts: District 16D Sponsorship workshop (March 11, Lawrenceville) and District 15B Traditions workshop (April 8,

- When you're finished recording, Press #, then you will be prompted to Press 1 to save your story.
- After that, press 2 to give AA Grapevine permission to use your story.

### Bridging the Gap

One of the best ways we can help newly recovering alcoholics transition from treatment to home is through the Bridge the Gap program. We want to help those who wish to get to attend a meeting upon their release but may not be familiar with local AA. The Bridge the Gap program allows treatment facility patients to request an AA contact in the area they live who then helps them find and attend a meeting. If you are in contact with a facility and want to talk with them about the Bridge the Gap program, let us know.

Our founders focused on carrying the message to other alcoholics in hospitals. They found that their prospects were more receptive when approached in this way. Today, some of our best prospects for recovery have already sought help through a treatment center. The Treatment side of our committee works with District and group treatment representatives to carry the AA message into facilities. If you are involved in taking the message into a facility, or would like to become involved, we are here to help. Come to our Assembly workshop or reach out to us through the Area website.

Can every member or prospective member in your District attend your meeting? The Accessibilities side of our committee helps groups make their meeting accessible to all who want to attend.

We look forward to seeing everyone at the January Assembly.

*"Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge."*

In light of the concept above, we will therefore be asking you, the body, at our Assembly in January to weigh in on the idea of offering "hybrid" access to our in person Area Assembly business meeting (and perhaps others) to allow those unable to travel or groups who cannot afford to send their GSR a full representation in the life of Area 16. More details will certainly follow, but we look forward to talking about this with you all in January at our Assembly workshops and business meetings.

May this new year be one of wonderful growth for Area 16, and for us all.

**Carrying the Message Behind Bars**

The Corrections Committee has several ways to get involved in service. One way is to carry the message into a state prison or local county jail. The state prisons require you to go through the approval process with the Georgia Department of Corrections. If you are interested in becoming a volunteer, you must first complete the training and application form on the website [www.gdc.gov](http://www.gdc.gov).

The local county jails have their own requirements, and you would need to reach out to the facility to confirm its process. We are slowly getting into the state prisons, but it wouldn't hurt to get your badge and be ready for when your local prison has an opportunity.

We also have correspondence and Bridge the Gap. These service commitments can be done from the comfort of your own home. First, correspondence is writing a person in a facility that has more than six months, and usually located at least two states away. Second is Bridge the Gap, in which a member corresponds with a person in custody by mail for about six months

and then meets the person after release to attend a few meetings together.

When a person in custody is released, they have a choice — an AA meeting or going back to their old lifestyle. The member basically helps the inmate understand Alcoholics Anonymous and shows the inmate where the spiritual tools can be found.

If you would like to become a Bridge the Gap correspondent, please let us know.

We also have the Pink Cans for your spare change that we use to purchase AA literature to provide to those in custody. The look on a person in custody's face

when you give them an AA Big book is priceless.

Please join us this year in doing service work in Corrections.

levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in reasonable proportion to the responsibility that each must discharge.

Do we understand the spiritual principles underlying "Right of Participation"? What does "in reasonable proportion" mean? These are some of the questions from the

Concepts Checklist provided in our General Service Material. How this all comes together for Area 16 is a work in progress. There is still a lot we don't know. We want to encourage all groups to participate with what is available now while we work to bring in other options in the future. There are many Areas facing these same challenges. Our Web and Communications Committees are prepared to move forward. We can help by participating at Assembly now to provide input from our members in Area 16.

In our AA Service Manual it says, "There is another good reason for "participation," and this one has to do with our spiritual needs. All of us deeply desire to belong. We want an AA relation of brotherly partnership. It is our shining ideal that the "spiritual corporation" of AA should never include any members who are regarded as "second class."

Deep down I think this is what we have been struggling to achieve in our world service structure. Here is perhaps the principal reason why we should continue to ensure "participation" at every important level. Just as there are no second class AA's, neither should there be any second-class world service workers, either.
