At the end of the day, we all have to decide if we are willing to work together for the people that haven't had the privilege we are enjoying today.

Ever a Vital Need," says in part; "Compromise comes hard to us "all-or-nothing" drunks. Nevertheless, we must never lose sight of the fact that progress is nearly always characterized by a series of improving compromises."

Communication is Vital! By Tom B. Area 16 Alternate Delegate

Communication is necessary within our Fellowship if we are to carry the message of AA to the suffering alcoholic. Our primary purpose, "to stay sober and help other alcoholics to achieve sobriety," is dependent on when and how we communicate. Our ability to share information between our members, groups, Districts, committees, Areas, and GSO, is vital to the survival of Alcoholics Anonymous. I'm sure all agree that we want AA to be here for the next individual in need of our experience, strength, and hope. Bill W. said in his 1960 General Service Conference talk, AA in an Era of Change: "When you think about it, AA is a unique means of communication: our lives have depended on communication; our unity depends on communication; our function depends on communication."

Where do you get your information about AA and our Fellowship from? Do you rely

on members, committees, group or District business meetings, literature, Area Assemblies, or GSO? What information piques your interest and what do you concentrate on? What do you pass along to others? In which areas of service are you involved? We must ask ourselves these questions if we want AA to continue to thrive. All types of information are floating around AA - the message of AA, events happening in AA, service opportunities, committee activities, workshops, social gatherings, groups and District business meeting discussions, conference agenda items, and Assembly focus. All these areas provide an important part to our Fellowship and how we carry the message. This information flows between us through different avenues.

One avenue of communication that I would like to highlight is Area 16's DCM Outreach Program. This initiative was born out of the "Our Voice Matters" exercise. The first DCM Outreach Committee was formed and began discussing communication strategies in 2021. It is a committee

made up of seven DCMs, each representing one of the Area 16 regions and District 17. There are four objectives of the DCM Outreach Program: 1) reach out to "dark" districts, 2) reach out to new DCMs, 3) provide guidance for Cluster Forums, and 4) strengthen our service structure overall by increasing involvement and participation. A Year in Review By Kelly G. Area 16 Treasurer

The office committee reported that our January Assembly was a great success at the new location. I am so disappointed that I was not able to be there with all of you after a year of waiting to be in person! However, I'm excited to join you in May in Dublin.

Our finances in 2021, as reported at the January Assembly, were strong. Our total ordinary income was \$238,208.45. We budgeted to receive \$262,016.47 or \$23,808.03 more income for the year; the shortfall is due to lower literature sales. Our total expenses were \$212,561.19. We budgeted to spend \$262,478.42, \$49,917.23 more. The decline in expenses was due to no in-person meetings or events. Overall, we netted \$25,655.27 for the year. I would like to thank all of you:

the members, groups and Districts committed to supporting GSSA in providing services that help alcoholics.

Our prudent reserve is currently almost 12½ months of operating expenses, which is slightly above our goal. The Prepaid Convention account remains at a good level as well. We have enough funds to cover the cost of four state conventions. We had an increase in the amount within the account after Jekyll Island's convention center refund was received. As the planning for the next Prepaid begins, we should see the amount in the account start to decline. Our contributions continue to remain steady.

<u>This issue</u> highlights important AA events, both in the U.S./ Canada and around the world. The issue also reports on some developments at GSO that will help AA members in custody and AA members on the outside to connect more quickly and to share experience, strength, and hope through correspondence.

Highlights from A.A.W.S

The AA World Services Board met on Friday, December 3rd, 2021, at the General Service Office in New York, with a vide-oconference/in-person hybrid meeting.

General Manager's Report

The general manager noted the recent Employee Recognition virtual event and the milestone anniversaries of employees celebrated for 5, 10, 15, 20 years of employment at GSO, remarking that their dedication to the mission of Alcoholics Anonymous is unparalleled.

The ongoing efforts to infuse AA principles into the daily life and operations of our office continue. The first in-house GSO 1728 meeting will be held on Friday, December 10. It will be held virtually and continue to be held on the second Friday of every month.

Archives

From January through October, the Archives staff responded to approximately 605 inquiries. Staff is currently aiding two International AA entities with their research inquiries. Italy has reached out to us for information about the start of AA in Milan and Japan has contacted us for materials on the history of AA in that country for their archives. These are extensive and time-consuming projects. Approximately 20 cubic feet of unprocessed materials from past International Conventions were brought into the archives for future processing. The archivist participated at the 65th Ohio State Convention, held on August 20–22, 2021. The theme of the Convention was "Our Great Responsibility," which was the topic of the Archives presentation.

 Ability to choose to receive digital or physical kits or to opt out of receiving any kits. The last phase of Release 3.0 is to provide area registrars the option to bulk upload information to Fellowship Connection.

Technology/Communications/Services

Website – The newly updated Alcoholics Anonymous (AA) website www.aa.org has launched.

GSO coordinates many services that help groups and members fulfill their purpose of carrying the AA message to the alcoholic who still suffers, and aa.org plays an important role in that work. Among the many benefits of our new website, it will serve as a significant resource for AA members, those seeking help from AA, professionals working with alcoholics, the media, and the public at large. Above all, it will provide consistent information about Alcoholics Anonymous.

Progress report on Meeting Guide App: The App team launched the third major application upgrade since App development was handed over to Foster Made. The App team has received positive feedback regarding this latest release, which included features requested by our users and entities, as well as code updates.

Conference

The Equitable Distribution of Workload (EDW) process has overwhelmed the Conference assignment. By September 15, the Conference desk received 178 proposed agenda items forms, some on the same items, which were all processed and forwarded to the appropriate committee/board for the fourth quarter General Service Board weekend. The first Conference planning meeting was held November 10.

Cooperation with the Professional Community/ Treatment

With the opening of events in the coming year, the C.P.C. coordinator put together a list including past events where we have exhibited and outlining upcoming opportunities to determine where we can be a presence in carrying information about AA to professionals. This list was reviewed by the trustees' C.P.C. Committee at their meeting October 31. The C.P.C. coordinator looks forward to working with local area C.P.C. committee chairs to volunteer for these events.

Corrections – The new Corrections Correspondence System (C.C.S.) launched in September 2021. The new C.C.S. provides an expedient process whereby we can match volunteers and persons in custody automatically, obtain statistics and reports, and generate personalized letters that can be sent via email to outside AA members and via postal mail to persons in custody. Since the launch, 267 were paired that for a myriad of reasons had been sitting in the old system. Phase Two will focus on added features and increased functionality.

Group Services – the Group Services coordinator and Online Intergroup of Alcoholics Anonymous. The vision moving forward is

continued support with each other in making Twelfth Step work possible. Group Services is working with manage-ment to finalize the plan for the 2021 Virtual Day of Sharing with at least ten other Twelve Step organizations.

Literature

A few of the preliminary Agenda Items for Literature are:

- Review draft language regarding safety and AA to be included in *Living Sober* and "Questions and Answers on Sponsorship."
- Review progress report regarding development of a Fourth Edition of the book "Alcohólicos Anónimos" (Spanish)
- Review progress report regarding the translation of the book Alcoholics Anonymous (Fourth Edition) into plain and simple lan-quage.
- Review progress report regarding development of a Fifth Edition of the book, English
- Discuss the existing version of the pamphlet "Twelve Traditions Illustrated."
- Discuss changes to the text of the book Twelve Steps and Twelve Traditions directed by the 71st General Service Conference.

Services available through GSO's Literature desk including providing resources to local AA committees, regional correspondence (Southeast), and secretary support to committees, continue to achieve success. This is the time of year when new panels of trusted servants are elected and GSO service desks, including Literature, welcome new chairs and provide service material to support their local efforts.

Nominating

The Nominating assignment coordinated the work of many groups on revisions to current Nominating pro-cedures and on scheduling interviews with new Class A candi-dates.

Public Information

A few of the preliminary Agenda Items for PI:

- Review 2021 annual reports from the trustees' Public Information Committee regarding aa.org and aagrapevine.org.
- Discuss feasibility study report on paid placement of PSA videos on streaming platforms.
- Review progress report on the development and implementation of a GSO podcast.

As of October 2021, a draft podcast pilot episode has been recorded and is being edited within our Communication Services Department. This will ultimately be reviewed by an internal Working Group as well as the AAWS corporate board and the trustees' Public Information Committee

Regional Forums, International Conventions and Accessibilities

The East Central Regional Forum, held November 19-21, marked the completion of four successful virtual regional fo-rums this year Forums in 2022 will return to in-person settings and may include a virtual component. In addition, planning for a virtual Special Forum focused on remote communities is underway with partners from Argentina and Chile.

FINANCE

The board accepted the October Finance department report highlighting the following information as of September 30:

Actual contributions are \$7,416,647, which is \$293,439 more than this time last year.

Gross literature sales are \$8,613,803 which is \$1,477,745 more than this time last year. Payroll and benefits are \$6,978,975, which is \$567,919 less than this time last year.

Total operating expense is \$11,543,559 which is \$512,887 less than this time last year. 2021 includes depreciation while 2020 does not.

Surplus for the first nine months of 2021 is \$1,448,089 (The surplus is attributable primarily to greater than budgeted literature sales).

Operating cash was \$1,687,249 which represents 1.3 months of operating expenses.

As of October 15, operating cash is \$1,551,246, which represents 1.2 months of operating expenses

Update Supply chain, paper, print and delivery disruptions 2021 – 2022:

Members and IGCO's (Intergroups and Central Offices) were notified the disruptions and delays are expected to continue. This is an industry-wide, world-wide issue.

Our Production and Member Services teams are actively addressing in myriad ways. Contact Member Services for help in ordering by emailing memberservices@aa.org

The Board Recommendations from Publishing:

- That the eBook Our Great Responsibility in English, French and Spanish be sold at a list price of \$9.99.
- That the reduced shipping test pilot be implemented as policy for the Publishing Department and requested that appropriate advanced announcement be sent to Central Offices and Intergroups by GSO management.

Technology/Communication/Services (TCS)

The digital production manager gave a demonstration of the new aa. org website scheduled to launch on December 20. Continued work will follow the soft launch, including ability to listen to books on the site and download PSAs along with refining search, accessibility and reporting capabilities.

The Group Services coordinator shared the newly completed New Group Form, which is being translated. New features include the option to list a meeting as inperson or virtual per the advisory action, "The U.S./ Canada General Service Structure recognize online groups and encourage their participation, listing those groups who ask to be listed within the group's preferred district and area, with the default option being the location of the group's primary contact.

"Other additions included hyperlinks: a free subscription to Box 4-5-9, a digital group handbook, lists of area registrars, and area websites.

Next to be updated is the Alcoholics Anonymous Group Information Change Form. met with key stakeholders. The DR/ BCP is expected to be completed for the committee's review in February 2022.

Grapevine Highlights

One of the preliminary Agenda items for Grapevine will be:

- Discuss the wide-ranging impact the Preamble change has had on our AA Fellowship.
- Financially AA Grapevine is trending ahead of budget and ahead of prior year on sales of both subscriptions and literature.
- La Viña is trending ahead of budget on subscriptions and on budget for costs. which are below the year prior.
- The AA message is certainly seeing growth in where and how it is carried. Additional outreach via Instagram and the new Podcast have generated fantastic traffic increases to both website and store.
- 5200 people have listened to the Podcast.
- . Instagram account for AA Grapevine has 4,752 follows to date, and it has had 110,000 impressions to date. La Vina's Instagram has just over 500 followers and is trending interestingly at about 10% of the English version, which is comparable to what we see in print and online.
- Prayer and Meditation is a proving to be a popular success.

• Thanks to the fantastic cooperation of the Corrections Desk and Grapevine Staff we are now directly receiving the list of inmates who have reached out for help from AA and can report that the GV is officially at a deficit of carry the message subscriptions. GV has received a list of over 2000 requests from the Corrections desk, and they have only 1,200 English "Carry the Message" Grapevine Subscriptions and 401 La Vina subscriptions in the pool. Please let those know that contributed their subscriptions that they are making it to prisoners and there is a need for more.

Additional Activities

The A.A.W.S. Board reviewed General Service Conference proposed agenda item submissions from the Fellowship for consideration.

- The A.A.W.S. Board to create an Intergroup-Central Office Committee (IGCO) manned by a non-rotating staff member.
 - The submission was tabled for discussion during A.A.W.S. Executive Session.
- That the General Service Conference consider a proposed agenda Item to produce the Service Manual, including the 12 Concepts, in a compact disc (CD), audio format, as has been done for the "12 and 12" and the book Alcoholics Anonymous.
 - The A.A.W.S. board took no action to forward this to the General Service Conference. Format changes are within the purview of the A.A.W.S. board. Therefore, the request and background will be sent to Publishing department for consideration. It was noted that we are consistently keeping front of mind the necessity of making available all AA literature in print, audio, and visual formats whenever possible.
- For the General Service Conference, thus the entire Fellowship of Alcoholics Anonymous, to discuss the most equitable and fair pricing model for both A.A.W.S. and Central Office/ Intergroups
 - The submission was tabled for discussion during A.A.W.S. Executive Session

A few of the Proposed agenda items agreed to be forwarded to the 72nd G.S.C., details pending the EDW process.

- Reconsider use of the term "person in custody" in AA literature.
- Consider request to revise the pamphlet "Questions and Answers on Sponsorship" to reflect shared experience on service sponsorship.
- Consider request to revise the pamphlet "The AA Group" to reflect the importance of the group as a "spiritual entity" as stated in the Long Form of Tradition Five.
- Consider requests that the chapter titled "The Doctor's Opinion" in the book *Alcoholics Anonymous* be returned to page one, as it was in the First Edition.
- Consider request to revise text in the chapter "Getting plenty of rest" in the booklet *Living Sober*.
- Consider request to add a historical disclaimer to the front of the book *Twelve Steps and Twelve Traditions*.
- Consider request to restore a paragraph in the story "Freedom from Bondage" in the book *Alcoholics Anonymous*.
- Consider request that all proposed changes to the book *Twelve Steps and Twelve Traditions* be handled in footnotes.
- Consider requests to limit changes to the book *Alcoholics Anon-vmous*.
- Discuss request to make AA literature changes slowly and with AA's primary purpose in mind.

As we move forward in this new year, I know that as our Fellowship faces challenges, we also have new opportunities to Carry the Message of Alcoholics Anonymous. Our willingness to work together is vital to our future.


















Guest Remarks, Tom H. (SE Regional Trustee)-

I am very grateful to serve with you as your Southeast Regional Trustee. When I was elected to the job in April, I stepped on to this fast-moving train. A train moving about 100 MPH, and I had to get up to speed, and I was very nervous about that. I still am, for that matter. I am in my first year and still learning stuff. Being a past Delegate, I know how Tracy must feel stepping into that roll. I just wanted to say that you belong, and you are going to be awesome, and the same for Tom B. Thank you guys, and thank you for your report, Tracy. It was awesome. Thank you, Haley, for speaking last night, and everybody who has done something here this weekend, and for all of those who might not have had a job here but are representing their district and home groups. I want to thank everybody a lot for that.

Did you hear about the Preamble change? Did you hear about it before hand or after hand? Were you upset about it? What about the Fifth Edition of the Big Book coming out? The Fourth Edition Spanish, the plain language Big Book? I mention all of those, and I want to speak to those a little bit, and let you know about some of that process.

There was an advisory action to create a Fifth Edition Big Book. It will not affect the first 164 pages of the Big Book, only the stories in the back and maybe an appendix or two. That is a long process. It took 4 or 5 years when they did the Fourth Edition. I know for the Spanish Edition, there has been a lot of help from a group of people making sure that the translation is done properly. My understanding is that maybe some of the translation in the current Spanish language edition could be better. The plain language Big Book, is an item people are interested in. There are companies that do that. It's not like a group of us are going to get together, and read the book, and make the changes. We are in the process of selecting a company for that project. If you didn't know about any of those changes, prior to them happening, I would encourage you to get more involved in service, because this stuff is important.

One of the things that I have requested is that the process be defined, and given to you, prior to the implementation of any action. So, 4 or 5 years from now, when they are ready to print the Fifth Edition Big Book, I want you to not be taken back by the process. I want input from the Fellowship. There are others on the board that want that as well. Things like how to submit a story, the timeline of the process, all those things should be on the table and talked about so you will know prior to it happening. Has anybody been to the new website (aa.org)? At the bottom of the website is a place for input. So, if you don't like something, or you do like something, or you have a suggestion for a change, please let us know at the bottom of the page under "contact us". When you open that link, you can contact your regional correspondent, or the website committee directly. I have heard a lot of great ideas over this weekend, and I have taken some notes, but it is better to hear from the "grass roots" of Alcoholics Anonymous. So, please send that email up and tell us what you like or dislike, of any suggestion you may have. One of the suggestions that I have heard already: for someone who is wanting to fine AA for the first time, it should be a one-click button. I should not have to click 5 times to find an AA meeting near me. Especially if we are half drunk and half interested in AA. By the time we get 2 or 3 clicks in we are back to the bottle. Suggestions like that are really good and helpful. So, please use that "contact us" link at the bottom of aa.org. There are different contacts for sending that information up. Did anybody notice the "accept cookies" button (or not) on the aa.org website? We had some talk about that recently too. AA is the fifth choice down when you do a Google search.

Why isn't it the first? Cookies and analytics are a part of that. Has anybody been around long enough to remember the days when they said that the internet is going to kill AA, web pages are the death of Alcoholics Anonymous? Now we are on YouTube, and we have Podcasts, and LinkedIn, and Instagram, we are all over the place. So, we are not as fearful of that anymore, but we still talk about privacy and anonymity with things like cookies and analytics. They are important in order for us to be the first search, but you can opt in or out. If you haven't read the privacy policy, or terms of use policy, and I know most of us don't, but I encourage you to read them, if you want to read them so you can explain them, should you get asked, they are there. Has anyone seen the new service manual? I heard there was a flash sale yesterday when I mentioned it at the "DCM 101", and now we are out of them. There will be more next time. Another thing to give feedback on in addition to the new website. If we don't hear what you want or don't want, how can we improve or fix it? At "DCM 101" we spent a good bit of time on Fellowship Connection. Patrick helped me a lot (Patrick was recognized by the body). Patrick was one of the few DCMs that had used his credentials and logged into Fellowship Connection. Liz mentioned the Directory, the two should coincide with each other at some point. DCMs have "read only" access to Fellowship Connection. If you go under the member section of aa.org, about halfway down the page you will see Fellowship Connection. There you can run reports and look at what groups are listed in your district. I think it is a very helpful tool, but it is a tool that many of the DCMs weren't using and didn't know they could use it. Please pass that information on. Tamera is very familiar with it. Tamera has more than "read only". She can actually make changes in it. I have pointed out Patrick, so wear him out. He knows all about it. Patrick is the expert on Fellowship Connec-

Finances, just really guick ... When COVID hit, and weren't meeting in brick buildings anymore, and we moved to the Zoom platform (or one of the many others out there now), we weren't passing the hat anymore. We didn't have to pay rent, and we weren't buying coffee or literature. Slowly, groups started to add Venmo and PayPal, using technology for contributions. I remember years ago as a fireman, we had to pay for our own staples like eggs, potatoes, salt & pepper, things like that. Every pay period we would throw \$10 in the hat to cover all that stuff. All the new guys were like, do you have PayPal? Cash app? Venmo? Nobody carries cash, and this has been going on for a while. When groups went to the Zoom platform and didn't have to pay rent, a lot of funds built up for groups and even this Area. We sent a 30-something thousand-dollar check to GSO because we had excess in this Area. Same thing with a lot of groups. So, contributions went through the roof. GSO asked for them and you responded. I am hopeful that trend continues. In my home group, when we pass the basket now, there is a laminated card in there for Venmo or PayPal, or different options. You see people scanning it and sending in contributions. So, I hope that continues and I want to thank you for your contributions to GSO. Those funds go to good use.

We are building up to a pre-conference event that Tracy will host. The DCM's have been assigned committees where they will see the agenda items that will potentially be discussed at Conference (not all are). The background material will be out mid-February, and hopefully your DCM has told you what committee your district is assigned to already. So, momentum is building for Conference. At Conference, Tracy will carry your voice, and potentially change some of what you ask or suggest to her on those agenda items based on new information that she

might receive at the General Service Conference. I know I did as Delegate, I'm guessing David did too (David M shaking head yes). You get up there, and just like at your own home group, you miss a business meeting and come back the following month and have questions about what happened, you missed some of the information. That is what happens at conference, and Tracy will be doing that soon. I know she is going to represent you guys well. I know she is nervous, but she is awesome, and she is going to be really good. So, this momentum is building, and I find it really exciting because it's all of the work we do culminates into these ideas that get presented to the General Service Conference. Some of them make it and some of them don't, some of them we don't like and some of them we love, and we can talk about that, and what I'm getting at is how important it is to have that diversity of thought. If Tom H. ran Alcoholics Anonymous, it probably wouldn't be a good thing. If you ran AA, and you got to decide everything, how good would Alcoholics Anonymous be? That collective group conscience is super important. I'm excited to see it work at the General Service Conference.

Lastly, there is this little storm that is going through the state right now that you may have heard of. Some of us, who may not be as sober as we actually should be, are still going to meet at Cracker Barrel after this and get food before we go back home. Old Business

Final Report from 68th Georgia Prepaid – Jekyll Island – 68th GEORGIA PREPAID CONVENTION

On October 15 through 17, 2021, District 3 held Area 16's first virtual Prepaid Convention which was originally scheduled to take place on Jekyll Island, Georgia. The difficult decision to go virtual was a result of the increasing number of Covid cases in our area, our inability to mandate mask wearing (a violation of Tradition 10) and adhering to the First Tradition that our common welfare should come first. We made this decision in the second week of September, which gave us only about a month to convert our program.

In the spirit of this year's theme, "AA in a Time of Change," District 3 blazed the trail of creating a virtual Georgia State Convention. There were, of course, some glitches, but there were many things that went well.

First of all, we had a very limited time period to get the word out. As soon as the flier was created, a copy was emailed to all DCMs, Georgia intergroups, and Area committees. In addition, Prepaid Committee members shared a copy of the flier and program with as many of our friends as possible. As a result, we had attendees from other states, including but not limited to FL, NY, MA, VA, PA. MD, OH, CA, NC, and TN. Other countries were also represented including, but not limited to, Ireland, UK, and Australia. It was a wonderful opportunity to share Georgia AA with the world.

Attendance was lower than we had hoped but difficult to calculate because a significant number of AA members participated together and groups like the Jekyll Island Group met and signed in under one account for all who were physically present. There were over 200 Zoom sign-ins for the evening speakers. It is also important to reiterate that the total cost of this convention was less than a thousand dollars.

The Webmaster and Web Committee increased the number of participants from 500 on our present Zoom account to 1,000. This obviously was not necessary, but it was good to have that cushion. Due to a technical problem, on Friday afternoon it was capped at 100 and there were complaints of not being able to get in, but it was quickly remedied by the Webmaster. Over the weekend, individuals also experienced their own technical issues, but things were easily dealt with. For example, on Friday night in the middle of the Sober Trivia game, Glen experienced computer problems, but he and Dave were prepared, and it resumed smoothly.

There were minor glitches in playing some of the videos, particularly the Archives presentation of Dr. Bob. The video was then broken into two portions, the first half playing during the dinner hour and the second half later. We should have had one committee member responsible for working with the technical people on the video programs. Also, a request of the tech team was to have a designated person in charge of screen sharing. We did not have one and it was a mistake.

Probably the best thing the committee did was to choose Voices and chair people who were experienced with virtual meetings and good at re-grouping quickly. A script was prepared for the Voices with, basically, bullet points. Each chairperson also received a script specifically for their meeting with detailed instructions and the Serenity Prayer, Preamble, and Lord's Prayer written out. Scheduling was difficult since we did not know how long workshops would take. We ended up with probably too much time between some meetings. Both the Friday and Saturday night entertainment should have been moved up closer to the last speaker

The Office Committee approved the suggestion that recordings of the convention be put up on our website and remain available until October. We would like to thank Damon for making that possible.

Suggestions and observations were solicited from participants. A summary is as follows:

- From the tech team (George and Nisha): The chat room needed to be a little more coordinated behind the scenes using a program like Slack.
- Low turnout was addressed by many. Was it because we did not get the word out sufficiently? Was it a political issue, i.e., mask/no mask or vaccine/no vaccine? Why was there a small number of young people?
- Some AA members from around the state came to Jekyll Island anyway and held their own meetings. Is there a way this could have been incorporated into our virtual convention if only by an announcement? Should future prepaid conventions include both face-to-face and virtual platforms?
- Everyone agreed that there was too much of a time lag between the evening speaker and entertainment. There also was a comment that we should have started later on Friday and ended later on Sunday.
- The "script" or "program" created for the Voices and chair people was praised for keeping everything flowing smoothly.

This convention would not have been possible without the incredible assistance of the "tech team": Paul, Dave, Chuck, Janie, George, Nisha, Damon and Micah. They helped with planning the program and, most importantly, they took shifts to facilitate the entire weekend. The committee thanked them with Jekyll Island gifts which cannot begin to reflect our appreciation of their hard work. We also could not have managed without the support and encouragement of our then Alternate Delegate, Jim T., whose patience was unsurpassed.

The committee would like to thank all who attended and participated in this ground-breaking convention which truly reflected AA in a time of change.

Bid for 2024 Pre-paid Convention: Jimmy M.

We couldn't do 2021 face to face, so we looked for the next opportunity, so it's 2024.

We are placing a bid for the 71st Prepaid convention in 2024 to be held in Jekyll Island.

The Jekyll Island Convention Center will be our venue and the dates will be October 17-19, 2024.

The venue capacity is 3600, the banquet room holds 2000, the room where the speaker dinner will take place holds 160. There are 11 break-out rooms for our use available.

If you haven't been to Jekyll in the last 7 years, it has changed tremendously. The list of events we are planning to host includes yoga on the beach, a golf tournament, putt putt, a motorcycle poker run, sober trivia, and a dolphin cruise. Other activities available are bike and walking trails, horseback riding on the beach, GA sea turtle center, the Jekyll Mosaic Museum, or visit the historic district.

We have 10 hotels with 1400 rooms on the island. The host hotel will be Home to Suites, also available are Day's Inn and Suites, Hampton Inn and Suites, Jekyll Island Club, Ocean Club, Marriott Courtyard, Residence Inn, Seafarer Inn and Suites, Villas by the Sea, and the Westin. There are also about 250 rental houses on the island should you want to get a group of people together and rent one of those. There is a great campground as well if you'd like to camp.

Room rates should run from around \$140 to over \$200 per night depending on where you stay and what type of room you select.

Conservative financial projections are that the convention will cost a net of \$79,067 after the projected income from out of state registrations and banquet ticket sales.
