Another winter Service Assembly has come and gone and just like that we are well into the new year. As I begin to anticipate the arrival of spring and the renewal that it symbolizes for the world, I can't help but be reminded of the spiritual renewal that must take place inside of every alcoholic who wishes to live a life in which they can be happy, joyous, and free. Though it doesn't seem like it, it wasn't so long ago that I would stumble (quite literally at times) into every new season of life. Trudging along and dragging behind me every hurt, resentment, fear, and the like from the previous seasons. Never realizing how detrimental my refusal to let go was to my emotional and spiritual sobriety. It was for this very reason that when I entered the rooms of Alcoholics Anonymous that I remained so sick for a time. That I was without a doubt spiritually dead.

I don't know about you but surrender and quit were not in this alcoholic's vocabulary. Even after admitting my powerlessness over alcohol and starting this beautiful journey into recovery, I struggled in those early days with the painful but necessary purging that comes from taking a spiritual inventory. Oh, surrender and quit weren't in my vocabulary but run and deflect certainly were.

I thought that I could escape the discomfort of turning my will over simply by omitting certain items from my house cleaning. I would find out the hard way that only a searching and fearless renewal of mind, body, and soul would do. And man was it uncomfortable! I had worn my resentments and fears and hurts like a suit of armor for so long that the shedding of that armor felt as though the skin were being ripped from my very being. It was painful but oh so freeing.

What I didn't realize at the time was how unbearably heavy those resentments were. How the refusal to let them go made me spiritually immobile. Nothing new could flow in until I became willing to release the stinking relics of my past. I stand here today, in anticipation and excitement for what is yet to come, all because I became willing to let go and surrender completely and for that I am grateful.

The most common question we get asked at the Treatment Committee is "my sponsor suggested that I get involved in treatment service work; how do I get started?" In most cases, we figure out which district they are in and put them in touch with the district representative for treatment, or their DCM where there isn't a representative. Another common question is "I just got elected as my district treatment representative, what do I do?" At some point, we all had no experience, but the purpose of the service structure and literature is to pass on our shared experience.

Our first suggestion for new treatment reps is to visit as many meetings as possible and ask the chairperson for a couple of minutes at the end of the meeting to talk with the group about your service position and the opportunity for service. Over time, you will find your people. Our second suggestion is to compile a list of hospitals, treatment facilities, homeless shelters, assisted-living facilities, sober houses, and other institutions where we may find alcoholics. Once you know how many folks you have and what facilities are in your district, you can coordinate with your PI/CPC rep to meet with the administration of the facilities to determine how we might cooperate with them to carry our message to their clients.

How can we make sure that the message of A.A. is accessible to every person who wants help? The Accessibilities Committee works with groups and districts to make AA more accessible to all. If you have an accessibilities question, please reach out to us.

We are currently planning to have our annual Area 16 Treatment/ Accessibilities **Workshop** this Spring. Keep an eye out for a date and time announcement.

Carrying the AA Message by Mail Dawn U., Chair Amber T., Co-Chair Area 16 Corrections Committee

The Forward to the Second Edition of the Big Book states "New groups started up and it was found, to the astonishment of everyone, that AA's message could be transmitted in the mail as well as by word of mouth.' This is just as true today as it was in 1955. People in custody love mail and look forward to mail call every day. What we often take for granted is a highlight of a person in custody's day. The corrections committee in Georgia has two service commitments that involve an AA member sharing their experience, strength and hope with another through the mail. You can do this service work from the comfort of your own home.

The first is the Pre-Release Contact Program in which an outside AA

member corresponds with a person in custody by mail for about six months or less. The member then meets the person after their release at a few meetings. The member basically helps the inmate understand Alcoholics Anonymous and shows the person in custody where the spiritual tools can be found. The second service by mail is through the Correspondence Program in which the member writes a person in custody in a prison facility on a long-term basis sharing recovery. The person in custody will be matched with you by GSO and will be about two states away. You do not have to use your address when writing. You can ask to use your correction committee, home-group or District's PO Box to correspond with the person in custody. We can only keep what we have by giving it away freely. The stories are legion in which inmates found the AA program through the mail.

AA is available to all who have a desire to stop drinking, and alcoholism certainly has no barriers, linguistic or otherwise.

District 17, Area 16's Spanish linguistic district, provides many services to its members, and at the District 17 Cluster Forum in November 2023, translation was provided in both English and Spanish. It was an incredible experience as the AA message was carried in both languages. When asked for volunteers to assist in translating archives material, nearly the entire audience pointed to one person, Paula M., who provides audio translation services at many Area 16 functions. However, is one person enough for this big responsibility?

At SSAASA, also in November 2023, a past General Service Trustee stated that if translation is not provided, then those who speak that language generally do not attend. The www.aageorgia.org website mission statement is "Provide information, tools, and services to meet

the needs of AA members, trusted servants, and the public in a simple, intuitive, secure, and **multi-lingual** manner via a web presence which is platform independent, measurable, and aligned with AA Traditions and Concepts".

How well are we fulfilling the multilingual part of that statement? Is just one person enough to handle audio translation for all the Area 16 functions? Is there a Spanish edition of The Georgia Message? What about agendas, or business meeting minutes, or function notices and flyers? What about workshops in Spanish?

AA World Services provide many items in multiple languages and platforms. La Vina is a great example of how to carry the AA message to the Spanish speaking alcoholic.



Panel 74 Delegate Committee Assignment

I received my committee assignment in mid-December. I am so excited to be a part of the Conference Committee for Grapevine/LaVina. There are so many fabulous new things happening with the Grapevine. It has branched out to be so much more than the monthly magazine that I was introduced to when I was newly sober in 1997. I have spent the last month getting acquainted with the AA Grapevine website, the new Grapevine app, the podcasts, the YouTube Channel, and the In-

stagram page.

The Grapevine Committee was formed in 1954. It is responsible for reviewing the development and circulation of the Grapevine at the individual and group level. Its members are invited to make suggestions and recommendations in any area of the Grapevine, including material and format.

The Grapevine App is doing very well. As of October 30th, there were 16,538 downloads, and 2327 subscriptions generating a net income of \$43,484.

The LaVina App had 596 downloads, and 70 subscriptions with a net income of \$831.

This App launched on September 1, so I will be interested to see where it stands after 6 months or a year. Already, Grapevine sits at #2 on the Apple top 200 list of Newspaper and Magazine App Charts.

Grapevine podcasts have had over 577,000 downloads.

Grapevine Instagram account has 10,900 followers, and LaVina has 1413 followers.

The YouTube channel has 11,900 subscribers, and 109 videos with 163,456 views.

International Convention

Vancouver will welcome A.A. members from around the world for the 2025 International Convention.

This will mark the 90th anniversary of the beginning of our Fellowship's founding.

The International Convention will take place from July 3 - 6, 2025, at the Vancouver Convention Centre and BC Place Stadium.

As the Convention approaches, you will find updates to the <u>aa.org</u> website with registration information.

There is an FAQ section in the middle of the page if you have questions or concerns about traveling to Canada

Let's celebrate sobriety together in Vancouver in 2025!

The International conventions and regional forums committee recommended that a digital option be added to the 2025 international convention, providing anonymity protected, encrypted, digital access to the Friday night meeting (including the flag ceremony), and the Saturday and Sunday big meetings, at a fee to be determined. The flag ceremony itself will continue to be offered at no charge.

The committee encourages those from outside of Canada who may have issues from the past that could prevent them from crossing the border begin the process of taking care of those issues as soon as possible. The FAQ section on the web page will address some of these issues

Public Information

The PI Committee got a progress report on the Mesmerize Point PSA Distribution channel.

They are playing 6 different 30-second PSAs, in both English and Spanish in Doctor's offices and pharmacies.

This gives us about 11 million viewings monthly.

Digital Press Kit

Includes information about Alcoholics Anonymous is the U.S./Canada Service Structure. The goal of the press kit is to answer questions and provide information about Alcoholics Anonymous for the media, professionals, and the general public.

This kit includes the anonymity memo to the media, an overview of the membership survey results, an outline of our service structure, and one click connectivity to a variety of digital resources. Some of these resources include the meeting guide app, AAWS LinkedIn page, and the AA Grapevine YouTube channel, just to name a few. It will be a great resource in the Public Information outreach effort.

Digital Literature Behind the Walls

Conference-approved AAWS and Grapevine copyrighted eBooks and audiobooks are available on tablets and desktops in the various correctional settings in the U.S. and can now be accessed by people who are incarcerated and by the professionals who serve them. Thanks to the 7th tradition contributions of members, we have contracts with several vendors so we can provide literature at no cost to persons behind the walls. The Daily Reflections audiobook has been added to the available literature.

The publishing department is organizing a tablet

demonstration so that staff members can better assist the fellowship and corrections professionals when they are confronted with issues trying to access the literature.

What can you do? Let correctional professionals know that we have contracts with many major tablet vendors. Literature is available in the "Recovery" section of the tablet.

Corrections

The committee reviewed recently collected shared experience on virtual meetings in correctional facilities and requested that staff develop a service piece for inclusion in the Corrections Kit.

The committee requested that a staff member attend the American Correctional Association

Conference in January 2024. A subcommittee was appointed to explore additional opportunities to share information about A.A. with corrections professionals.

Reserve Fund

As of October 27, the net reserve fund balance is \$12,562,214, or 7.26 months of operating expenses.

Cooperation with the Professional Community Work continues on the pamphlet for mental health professionals.

The LinkedIn page continues to inform profession-

als about A.A. and has seen a 50% increase in followers since July 2022 (over 3400 followers to date).

The committee looks forward to the CPC Service Cards being made available to the Fellowship in a digital format, with physical cards to be printed later this year.

Literature

The trustees Literature Committee is seeking stories from AA members with diverse backgrounds. This is in response to the 2022 Conference Advisory Action that the trustees, Literature Committee revise the pamphlet "Do You Think You're Different?" to update the stories to represent greater diversity.

The suggested format for typed manuscripts is 500 -800 words, double spaced, in 12-point font. Handwritten manuscripts should be approximately 5-6 pages.

These are due before April 30, 2024. There is a QR code on the screen that will take you to a digital submission form. The email and link are also on the slide. I will include the email, the QR code, and the link in the delegate's report that will be available on our website by the end of the month.

In response to a Committee Consideration from the 73rd General Service Conference (2023)

suggesting that trustees' Literature Committee seek input from the Fellowship (including

but not limited to Area delegate feedback) regarding any possible future changes to

literature written by A.A.'s Founders, the trustees' Literature committee agreed it would

be beneficial to gather shared experience from the Fellowship regarding this topic.

We would like to hear from you – the top of the triangle! While we hope that the suggested

questions will help to spark thoughtful sharing and discussion, please feel free to add

questions that we may not have thought of that you feel may best inform the discussion.

Most of all, we are grateful for and thank you for your participation.

The AAWS Highlights are back in print.

One of the challenges of the COVID pandemic was the suspension of printing the AAWS Highlights

newsletter. But it is now back in production and will be distributed after each board meeting. The Highlights can also be accessed on the <u>aa.org</u> website under the Inside AA," what's new" section. The Highlights offer consistent communication between the General Service Board and the Fellowship.

Regional Forum

Regional Forum events allow members throughout the service structure to exchange information. They bring together:

Started in 1975, these unique gatherings happen four times a year. Each forum occurs in one of the eight regions of the U.S. or Canada. The regional trustee, area delegates and GSO decide on the location and agenda for Regional Forums. Together, the forums coordinator at GSO, the local A.A. host contact, and the regional trustee coordinate the details of the Forum.

This year we will have the Southeast Regional Forum in Biloxi, MS, December 6-8. I will let you know when registration opens.

We've taken more than 100 of your most frequently asked questions and developed a central resource where you can access them, their answers, and links to related information. Over time this list will grow to include even more helpful, searchable information.

You can find the link to the FAQ page at the bottom of every web page on the <u>aa.org</u> site.

The literature committee reviewed a progress report regarding the development of a fifth edition of the book Alcoholics Anonymous. The committee discussed concerns related to the management of the substantial number of stories submitted by the fellowship and the involvement of additional readers to streamline the reading process. The committee agreed to establish a reading working group composed of members of the fellowship selected by

the committee and that working group members be required to sign a non-disclosure agreement to protect the integrity of the publishing process.



The 71st Ga State Pre-Paid Convention will be held Oct. 18th, 19th, and 20th, 2024 on Jekyll Island. District 3 is honored to be able to host the convention this year. As most of you know, we hosted the 68th Prepaid convention, but due to COVID, we had to hold the convention virtually. We are excited to have another opportunity to be able to host the convention and look forward to seeing everybody in October.

The theme for this year's convention is "Connecting with Love, Unity, and Service"

The convention will be held at the Jekyll Island Convention Center, which is a great facility. We are planning a walk thru next week to reevaluate space. The projected expense for the Convention Center is significant. The Food and Beverage minimum is about \$30,000, this was negotiated down.

The hospitality room will be at the Home 2 Suites, which is the host hotel. There is a really nice room there and they will allow us to bring food in. We will be working with groups to provide food.

The registration form is currently live online at AAGeorgia.org. There are also paper registration forms. We are encouraging everyone to use the online forms (it eliminates having to rekey the information). During the Augusta convention we registered 163 and have 54 online registrations for a total of 217. Registration at the convention will open Thursday afternoon for early arrivals.

We are still working on the program. We will have 5 main speakers plus an Al-Anon speaker. In addition, there will be local speakers concurrently with workshops (this was done at the

Augusta convention and everyone thought it was a good idea, it gives people a choice).

We are planning 3 workshops and some discussion meetings. The convention will actually start Friday. However, we are planning a discussion meeting Thursday evening for early arrivals. There will also be an Al-Anon discussion meeting Saturday afternoon.

1. Discussion, vote. Motion-Coins for Cons. (Tabled at September Assembly)

Motion introduced at the September 2023 Assembly by David J., GSR Thompson Group;

That the assembled General Service Representative instructs the treasurer to include in the regular Area 16 Financial Report the following balances related for Coins for Cons contributions-

Beginning Balance of the Coins for Cons Account at the beginning of the reporting period.

Total revenues during reporting period

Total expenditures during the reporting period

Expenditure for requests from individuals during the rep[orting period

Expenditures for requests from institutions and organizations during the reporting period

Ending balance of coins for cons account at the end of the reporting period

The treasurer shall choose the reporting period based upon accounting needs, but the reporting shall be presented each Assembly.

Chairperson Tracy M. asked for more discussion on the matter-

Floor discussion

<u>Erica, GSR Flint River Group</u>- Asked for clarification regarding what the reporting period would be and asked if the information was already presented in the budget or posted anywhere else.

Tracy M. clarified stating the information was not in the budget and is contained within the Corrections Committee. As for the reporting period, the motion states that the treasurer would choose the reporting period based upon accounting needs.

Tori, GSR for 14C Canton Group- Asked for clarification on the difference, if any, in regards to the 'pink can' and Coins for Cons. Also asked if Coins for Cons was an actual 'sanctioned' part of AA, or if it is an outside organization with which Area 16 partners with.

Tracy M.- Stated that the 'pink can' and

Coins for Cons are the same thing.

Coins for Cons is *not* a part of Area 16. Asked for Tamera of Dawn to come to the mic and give further clarity.

Tamera P.-Explained that Coins for Cons was created by the Corrections Committee. Funds from Coins for Cons are only to be used for the purpose of purchasing literature going into the jails. Is *not* a line item in the budget. Groups send money only for that purpose and funds are not used for anything else. The Corrections Chair sends out the financial report regarding Coins for Cons. Information is also presented at Area Assembly.

<u>Brian, Early Risers Group 16D-</u> Asked if the purpose of the motion was to create greater transparency.

David J., GSR for the Thompson Group-Clarified that the motion was made with the intent to create transparency and in order to ensure funds are going directly to inmates in need of literature in the jails.

Allen J., GSR Swainsboro Group - Stated that anytime money is involved that money needs to be accounted for. Expressed that the body has a right to know where and to whom the funds are being distributed. Believes that spreading the message literature is one of our most powerful means of carrying the message to the alcoholic who still suffers.

Chris, GSR Sunrise Group 16B- Their district does not operate by sending Coins for Cons money to the state. There is a separate account that specifically holds those funds and whenever their corrections committee needs to buy literature, they make a request through the treasurer to remove that money and pay for the literature that is being distributed. This is done autonomously through the district.

Asked what the state's part in Coins for Cons, does it need this, or is it solely a district by district process that would be autonomous to different groups?

<u>Jessica</u>, <u>DCM 7B</u>– Question for Tamera or Dawn, is there a reporting of the Coins for Cons account and is it available by Corrections? Is it posted in the AA Message, and how often.

<u>Dawn</u>, <u>Corrections Committee Chair</u>— Clarified that the reporting of Coins for Cons money is available at the corrections workshops held during assembly and also presented at the GSR workshop of Saturday. As far as she knows all literature being purchased is going directly to the hands of the inmates, not a library.

Rusty L. - Asked for confirmation that Coins for Cons is not an AA affiliate. Being that it is not an actual part of alcoholics anonymous, there is concern that we are commingling money within GSSA's accounts for a truly unaffiliated entity. Though Coins for Cons is fantastic in its own right, he is concerned that it's commingled in GSSA accounts and we don't do that with any other outside organization.

Recommended that Coins for Cons should possibly have its own separate account. of funds with Coins for Cons (outside entity) Possibly need its own account.

Tamera P., GSSA Office Manager- Stated that the report for Coins for Cons is always available on the website. It's called the balance sheet and it shows the line item for Coins for Cons. Each group who contributes GSR receives a receipt for the contribution.

<u>Amy S., GSR Greenhouse Group 16C-</u> Called the question

Penny, GSR Serenity by the River-Seconded


