General Service Conference By Debi K. Area 16 Delegate

By the time you read this, I will have attended the 71st General Service Conference (virtual) and will be preparing my report to give to you at the May Area Assembly. It has definitely been an interesting year. We have transitioned to virtual spaces, worked with newcomers, continued to do the business of Alcoholics Anonymous, and remained sober. It is through the grace of my Higher Power and the principles of our program that I have continued to grow in my recovery and continued to serve.

I wanted to focus this article on the General Service Conference (GSC). The GSC may seem far removed from some of you but is a vital part of our three legacies. In 1954, Dr. Bernard Smith, a non-alcoholic trustee who chaired the trustees' board, stated the following at his opening talk:

"We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight — destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in AA that rebirth that brought us back to life.

We need it because we, more than all others, are conscious of the devasting effect of the human urge for power and prestige which we must ensure can never invade AA. We need it to ensure AA against government, while insulating it against anarchy; we need it to protect AA against disintegration while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Tradition, and its services.

We need it to ensure that changes within AA come only as a response to the needs and wants of all of AA, and not of any few. We need it to ensure that the doors of the halls of AA never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is." (AA Service Manual S20)

Final Responsibility and Ultimate Authority By Jim T. Area 16 Alternate Delegate

As I write this article, we are finalizing our Pre-Conference discussions to help prepare Debi, our Area 16 Delegate, to attend the 71st General Service Conference. This process has involved the Office Committee, numerous past Area Officers, the Area Chairs and Co-Chairs, the DCMs, GSRs, and the AA groups all across Georgia. Our discussions center around developing our group conscience on what are called "Agenda Items" for this year's Conference. These Agenda Items are simply ideas or requests that have been submitted to the General Service Office by Areas, Districts, Groups, or even individual AA members across the U.S. and Canada since last December.

The involvement levels in this process around the state have been, as you might imagine, varied. Some

groups and districts have been really interested and others, not so much. This is all well and good because I don't know of another organization that allows its members so much freedom to decide what they will participate in and what they will not. I have heard comments like, "that's only important for the folks in New York", or "that's only important for those folks in Macon". Experience has taught me differently. The upside down (or inverted) triangle that depicts our service structure, puts the AA groups at the top, followed by our districts, areas, Conference Delegates, and General Service Board. This means the AA groups play a critical role in ultimately directing AA's future.

Tradition Two states that "For our group purpose, there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern". It is only through participation of the AA

SELF-SUPPORT GROUP CONTRIBUTION PLANS TO AA SERVICE ENTITIES

"To help support AA's essential services, the General Service Conference suggests that individual groups, through an informed group conscience, adopt a specific contribution plan tailored to meet the group's financial situation."- Self-Support: Where Money & Spirituality Mix

Congratulations to District 11C, which joined a few other districts in Area 16 in carrying the AA message to DUI schools by way of Zoom.

We encourage District PI/CPC chairs to contact DUI schools in their area to let them know we are available for virtual talks at non-AA meetings. Some Instructors say they plan to return to face-to-face meetings soon but if Covid-19 does not subside, they will consider virtual talks by AA members.

When reaching out to DUI school staff and instructors, we first let them know we are unpaid volunteers and that we only carry the AA message. Our main purpose is to let the students know AA is available in the community for those who have a problem with alcohol, and they can attend a meeting with the use of a smartphone, tablet or computer.

DCM's who do not have a PI/CPC chair can announce at their district and group meetings the importance of PI/CPC work for those willing to serve. The Area 16 PI/CPC chair and co-chair are available to assist those who are new to PI/CPC and those who would like more information on how to get started. After registration at the district and group level, the information is sent from the state office in Macon to the General Service Office in New York. The volunteer will later receive a PI and CPC Workbook from the General Service Office. Some helpful pamphlets are: "Speaking At Non-AA Meetings" and "How To Do PI/CPC Work".



Your GSR (Group Service Representative) shares your approval or disapproval of the agenda items at the district meeting. The DCM (District Committee Member) brings the groups' wishes to the Pre-Conference meeting. At the Pre-Conference meeting, DCMs, Committee chairs and co-chairs, and the Area Officers come together to discuss each agenda item, share ideas from their groups, and make recommendations to the delegate. These recommendations

are vital to me as they become part of my thinking at Conference, where I can provide input and ask questions. I use the information you provide along with the information I learn from my fellow delegates to make an informed decision before I vote for a recommendation to become an Advisory Action.

That is why your group input is so important and why the groups are actually not far removed from decisions made at our General Service Conference. Without you, the system is broken. So many of you reached out to ask clarifying questions and offer your thoughts on agenda items that resonated with you. I love hearing from you and have enjoyed these conversations. I appreciate your continued interest and dedication to our service structure. We want to ensure that any changes to AA are a response to the needs and wants of ALL of AA.
