AA in the digital age

Alcoholics Anonymous is moving into the digital age. The AA Grapevine is now available as a digital magazine for a reduced subscription fee of \$19.97 per year (\$9.97 for La Vina). GSO is delivering its three newsletters, Box 4-5-9, About AA and Markings, digitally to anyone that would like to receive them via email. By the end of the year, our Big Book and Twelve Steps and Twelve Traditions will be available in eBook format. We will have our own mobile app to purchase, download and view the eBooks. All of these publications will continue to be available for purchase in the paper format.

In Area 16, Georgia, we are moving into the digital age too. The GA Message (our newsletter), Georgia Service Manual, and Service Directory are available on our website. In addition, we post all Area documents for AA members to access. Any document that has full names, addresses or phone numbers is secured with a login and password. We have transitioned our newsletter to be anonymous so that it can be made available without

a login. Visit www.aageorgia.org to check out the information available. Ernie M., our Area Secretary, has collected email addresses for all of our DCMs. We're hoping to move towards electronic communication to the Districts. This will enable more frequent communication.

As we move slowly towards the digital age, it is as important as ever to stay informed about our Traditions. They all apply to this new world. We also need to understand that ALL AA members have a voice in AA. I know that the internet and Facebook can be very threatening for some of us. Get involved and get education. Let your voice be heard. We have our Concepts that outline how our organization functions and how our Conference is the voice of AA as a whole. General Service is a great way to get involved and be a part of AA as a whole. If you don't know what General Service is, pick up an AA Service Manual and find out. For the months of May and June, we will take a look at Concepts V and VI. Consider the questions under each in your Home Group. Talk to your GSR if you don't know the answers to these questions.

Concept V: Throughout our structure,

to our continuity, I would say, the Concept of Anonymity."

Bill ended his last message with, "...I deeply believe that the principle of anonymity must remain our primary and enduring safeguard." The experiences of trial and error in the early days of our fellowship were written down in 1946 as the 12 points to assure our future. If the traditions were thought of more often as points to assure our future than perhaps they would be adhered to more often and with more reverence. It seems to me that more and more, as a collective membership, we are running away from assuring AA's future where anonymity is concerned. And just because so many of us seem to be running in the same direction this does not mean it's the right direction! Much of our literature speaks to main-

a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

- Do we encourage the minority opinion, the "Right of Appeal", to be heard at our home group, district committee meetings, area assemblies and the Conference?
 - What does our group accept as "substantial unanimity"?
 - Has our group experienced the "tyranny of the majority" or the "tyranny of the minority"?
 - Does our group understand the importance of all points of view being heard before a vote is taken?
- Concept VI: The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- Are we familiar with how our General Service Board (GSB) Class A and Class B trustees serve AA? Are we familiar with how our other trusted servants serve AA?
 - Are we clear about the terms, "chief initiative" and "active responsibility"? Can we see a direct link to our home group?
- See you at the Assembly in May.

Most of the methods for breaking or maintaining anonymity in various settings should seem fairly straight forward and I cannot begin to address them all in this article. So, I will speak to one of the most common sources of anonymity breaks in today's AA and that is social networking sites.

I remember first getting on Facebook and uploading photos of me at GSO, Stepping Stones, Dr. Bob's House, and various other AA landmarks and conventions. I had a sense of pride and "showing off" instead of a grateful humility that I had been blessed to visit these places. I might as well have made my Facebook name, "I am a

Getting involved!

Greetings from the Area 16 Corrections Committee. We are writing a series of articles for the Georgia Message of AA to describe what our fellowship does in the Corrections area and what opportunities there are in Corrections for any of our members who might be interested in getting involved.

AA Guidelines for Corrections Committees, as published by the General Service Office, state that "the purpose of a Corrections Committee is to coordinate the work of individual AA members and groups who are interested in carrying our message of recovery to

alcoholics behind the walls, and to set up means of smoothing the way from the facility to the larger AA community through prerelease contacts".

Historically, the fellowship of Alcoholics Anonymous was in its seventh year when a pioneering warden at San Quentin asked nearby AAs to carry the message to alcoholics in the prison. The year was 1942 – the warden was Clinton Duffy. He was heard to say, "If the AA program will help just one man, I want to start it." As of 2006, AA estimates there are over 2,500 groups located in prisons in the U.S. and Canada, with a membership in excess of 65,000 inmates. This information comes directly from our conference-approved Corrections Workbook.

Today, the Area 16 Corrections Fac-

ility Committee focuses our attention on three main areas of service. These are 1) Correctional Facility Meetings, 2) The Bridge the Gap Program, and 3) The Corrections Correspondence Service. We will discuss each of these services in detail in the next three issues of The Georgia Message of AA.

State Office, Macon – 50%
GSO – 30%
Pre-Paid Convention- 10%
District/Zone – 10%

In Atlanta, Augusta and any other District/Zone which supports a central office, we suggest that the income, after all group expenses have been paid, be allocated as follows:
Central Office – 35%
State Office, Macon – 30%
GSO – 20%
Pre-Paid Convention – 10%
District/Zone – 5% or whatever percentages are in accordance with your group conscience.

friends.

Today I check my Facebook private settings often, I un-tag myself in photos that break my anonymity, I un-join groups that I have been added to without my permission (whether they are a secret group or not), and I politely ask friends not to break my anonymity when they do so. It is a constant vigilance but well worth it and in doing so I display my respect

for AA today and for tomorrow. If you haven't thought much about anonymity lately I encourage you to give it some thought and perhaps we can all be running harder in the direction to assure AA's future.
