On April 2, 2022, DCMs and Area Service Committee Chairs and Co-Chairs gathered at our yearly Pre-Conference meeting. Each one is assigned to a Pre-Conference committee that is made up of seven or eight DCMs and the respective Area Service Committee Chair and Co-Chair. They all met to share the voice of AA members in Georgia with our Delegate on the many different Agenda Items scheduled to be discussed at the 72nd General Service Conference. Our Delegate will attend the Conference at the end of April in New York City to be part of this weeklong meeting of 93 Delegates, 21 Trustees, and many GSO staff members. She will carry

Georgia's informed group conscience as well as utilizing her "Right of Decision" (Concept 3) to aid her in making an informed decision about each Agenda Item presented at the Conference.

How are the Conference Agenda Items communicated to you? Each February, the Conference Agenda Items and their background information are sent out to all 93 Delegates for the upcoming General Service Conference. Our Delegate then sends the list of Agenda Items to all the DCMs and Area Service Committees for feedback from their respective District and Service Committee. Each DCM has a group of Agenda Items from their assigned Pre-Conference committee to be shared and discussed with the GSRs in their District. The GSR then takes this information back to their home group

Financials: First Quarter By Kelly G. Area 16 Treasurer

I had the honor of meeting with a group of DCMs in Macon for our Pre-Conference meeting to discuss two Conference topics: Finance & International Convention/Regional Forums. This is my second year doing this, but my first time being able to do it in person. I am very grateful to the DCMs I met with and the input they provided from their Districts. I feel that Tracy will be well-prepared to share our Area's conscience.

I would like to give a report of the first quarter of 2022. Our ordinary income is \$45,877, which is about \$1,659.78 under our goal. Our expenses were \$40,239, which is \$15,872.58 below the budgeted amount. Our literature sales income is

sitting around \$20,000, which is \$658 less than budgeted.

In 2021, we made a strong budget for the 2022 year, and I am happy to report that the groups and districts have answered with support. We are close to hitting all our budgetary goals.

Georgia is the only state that holds a Pre-Paid Convention. Our conventions are paid for by contributions from groups and districts so AA members from in state do not have to pay for admission. Because of generous contributions, we have a balance of \$182,399 in the account. Using an average cost of the last three inperson Pre-Paid Convention, this would cover approximately 4.3 conventions.

Our contributions to date are over \$9,000, which is an increase of 30% since last year.

A Desire to Stop Drinking By Liz W. Area 16 Secretary

I have heard it said that Alcoholics Anonymous is a microcosm of society at large. This seems to be true, as we have people from all walks of life, all ages, all genders, all races, all religious beliefs, all political affiliations, and I'm sure there are more things that I left out. But the beautiful thing about Alcoholics Anonymous is that none of those things matter once we walk into a meeting. When we sit in that seat, the only thing that matters is that we all have a desire to stop drinking. What a relief. And it's the only requirement for membership too!

What a fabulous opportunity for people "who normally would not mix" to get to know and grow with each other. I look back on the last 25 years and I am astounded. In some ways it seems like it was just yesterday that I walked through these doors, and in other ways I see how much has happened from then until now. Most of it involves service in Alcoholics Anonymous. There are very few service opportunities that I can honestly say I was glad to be finished with. Most of the time I was just getting the hang of

it when it came time to rotate out. But rotate I did, and I started something new as soon as I possible could. Service work has been the foundation of my recovery.

I simply can't imagine what my life would look like today had I not taken the suggestions to get involved. Heck, I was willing to take just about any suggestion that was handed to me. For the most part, I still am. This journey hasn't been the smoothest. Life has still happened. Family members have passed on, people I loved have chosen to drink again, a sponsee paid the ultimate price, groups have folded, and others have started up, and life goes on. I have found that as long as I don't make everything about me, I can be useful in any tough situation.

The gifts of this program are not limited to just staying sober. I was told that the more I put into my recovery, the more I would get out of it. I believed that then, and I believe that now. I used to have to do something every day to be able to drink, and I must do something every day to stay sober. As long as I stay active, I believe I will continue to be happy, joyous, and free.

To become a volunteer for a state facility, you will need three years off probation or parole. You will need to go through the state's Department of Corrections training. The first step is to complete their online application on the website www.dcor.state.ga.us. Under the main menu there is volunteer services section. You will need to watch a short video and complete the application. Once the application is complete and approved, you will be notified to take part in a training session in Forsyth, Georgia. Once that training is completed, you will leave with your badge.

The informed group conscience of each assigned committee is presented to all attendees of the Pre-Conference meeting and recorded in writing for the Delegate.

This communication chain of information from Delegate to AA member-atlarge and back to Delegate is an invaluable process when used effectively. Our trusted servants at every position of this communication chain need to be diligent and available so that your voice is heard.


