I have been following the developments of the spread of COVID -19 (Coronavirus) and considering the impact it will have on recovering alcoholics as well as the service entities of Alcoholics Anonymous. We are now faced with a global pandemic that has affected our ability to attend face-to-face AA meetings but also has presented many of us with other pressures. This is not a situation any of us could have expected.

To support a program built around

the simple idea of two alcoholics sharing their experience, strength, and hope; and for a Fellowship framed by hugs, hand-holding, tight rows of folding chairs, meeting greeters, and sharing from the heart, what we have done to face the new reality of COVID-19 isolation is truly remarkable!

In a matter of days, groups from all over the State of Georgia have started virtual AA meetings using a variety of platforms. These meetings were initially announced through social media and simple word of mouth. They are now posted on our Area 16 website, Intergroup websites, and the Meeting Guide app. I have witnessed newcomers attending these virtual meetings. I have attended virtual meetings from all over the country with as many as 100 attendees. We are still carrying the message of Alcoholics Anonymous and supporting

Firstly, I hope this edition of the Georgia Message of AA finds everyone safe, sober, and healthy. The month of March is one to go down in history for us. We have seen cancellations of group meetings, a Cluster Forum, the Pre-Conference meeting, an Area Workshop, the 70th General Service Conference, and the 2020 International Convention in response to the coronavirus. And that's just so far. As disruptive as this pandemic may be, I have been in awe of the resilience, courage, and creativity of our groups and members to not only keep Alcoholics Anonymous in Georgia alive, but to keep it moving forward throughout this crisis.

a presentation at Unity Weekend in Lawrenceville during the last weekend in February. My assigned topic was "Attracting and Retaining Those in Need of Recovery". I began my research for the presentation in the AA literature and on the <u>aa.org</u> website. Some fascinating information came to light as I began to look into our past and I would like to share some of that with you here.

Estimated worldwide AA individual membership data revealed some interesting trends: AA membership from 1935 to 1965 grew slowly from 2 to 232,105 members (an average increase of 7,737 new members per year).

A rapid period of growth in our Fellowship occurred from 1970 to 1990: AA went from 311,450 to 2,047,469 members (an average increase of 86,800 per year) and Confidential for members May/June 2020 Volume 56, Numbers 5-6

Preparing for When We Can Help Again

Currently, we are at a standstill. The treatment facilities are not allowing anyone to bring a meeting to their facilities due to the coronavirus. They are holding meetings in-house on their own. That being said, now is a good time to review some past suggestions on how to get started carrying the AA message into a treatment facility.

- 1. Attend District/Zone meetings and talk with your District Treatment Rep. He or she can share how they got started.
- 2. The Treatment Workbook is a good source of information on how to approach a program director, along with many other subjects.
- 3. Volunteer to go with one of the committee members to a facility.
- 4. We have a workshop at 11 a.m. on Saturday at Assembly.
- 5. Review AA Guidelines (Treatment Facilities Committees, MG14).
- Review AA Guidelines (Accessibilities for all Alcoholics, MG16). This publication has information about carrying the message of AA to the deaf or hard of hearing, the homebound member, and/or the member who is blind or has low vision. It also has an accessibilities checklist for meetings and groups.

Treatment and Accessibilities has begun to send out a newsletter every other month. This newsletter will answer questions you may have, or it is a way you can share with us how you are working with the treatment facilities in your District/Zone. It will contain information on making AA groups accessible to everyone, no matter what their barriers may be (Bridging the Gap, etc.). Sharing your experience with us will help us

Our job in Archives is to remind ourselves and others in our Fellowship what it used to be like, what happened, and what it's like now. Before our Fellowship, we alcoholics were destined to live a life of misery, then die a lonely alcoholic death. Bill Wilson, an alcoholic struggling to stay sober, decided to pick up a phone rather than a drink. Then through a series of seeming "coincidences" that proved to be an act of provenance, Bill was introduced to Dr. Bob Smith, a struggling but still wet alcoholic. Both men stayed sober and lived happy and very productive lives. It was from that relationship that our Fellowship was born on the premise of one alcoholic helping another; both men could recover from a "seemingly hopeless state of mind and body".

The telephone was the tool used to allow this to happen. In 1935, when this all began, telephone communication was in its infancy. Bill used a pay phone outside the bar at the Mayflower Hotel, which cost a nickel. My, how times have changed.

I believe our co-founders would be amazed at the wireless communication of today. We carry a device in our pocket that allows us to instantly contact almost anyone on the planet while still serving the same purpose as the one Bill used that fateful day. Let us never forget that picking up a phone is always a better alternative than picking up a drink.

Oh, No! Change By Ken P., Chair David J., Co-Chair Area 16 Corrections Committee

The State of Georgia Corrections Training is seeing some changes. As always, some are beneficial, and some are challenges. The most beneficial change coming is that you can leave future training with a five-year badge that only needs annual paper updates along with PREA training.

With the retirement of our longtime trainer in December, AA is now fully integrated into the regular Georgia Department of Corrections (DOC) digital training process. The DOC has a three-step training program. First, a website introduction to the training process is provided. Second, there is a formal submission of background check information. Third is group training. (Bring your lunch.)

The Corrections Committee hopes to have a step-by-step guide to the process

on our website by the time you read this article. There are opportunities for AA members to have individual training, but we will have to have at least 25 people at a training session. We are expecting that the state will have additional training sessions scheduled shortly.

We thank everyone for working through this transition period. Please keep up your enthusiasm as we work towards a regular process.

An Opportunity to Communicate

"When a few men in this city have found themselves, and have found the joy of helping others to face life again, there will be no stopping until everyone in that town has had his opportunity to recover — if he can and will." — Alcoholics Anonymous, pages 163-164

Communicating can be hard work, not just for the transmitter, but also for the receiver. Both need to be ready and willing to make the effort to share. How bad does it have to get for some of us to become willing?

One of my favorite acronyms is G.O.D., or Gift of Desperation. As difficult as the past weeks have been for folks in sobriety, it has to have been worse for folks still drinking. Offices and workplaces have been closed, but the liquor stores have been open. I believe that many people in our communities have been in the process of finding G.O.D.

We have seen the power of one person sharing with others, and seeing it shared around the world in a matter of months. There will soon be many who are ready to hear that message for the first time.

Don't doubt the power that we have as recovering alcoholics to communicate a message of hope to others who are still suffering.

represented the most expansive period of growth in our history.

Interestingly enough, from 1990 to 2019, something happened, and our growth slowed down to the lowest we've experienced since AA's infancy during the period 1935-1940. Since 1990, our growth has been basically flat, increasing by only an average of 655 members per year (from 2,047,469 in 1990 to 2,130,419 in 2019).

This intrigued me and I began to wonder if we're experiencing a growth problem, a retention problem, or perhaps both? Since AA does not keep attendance records, these numbers from the General Service Office in New York are only estimates from group records, but the trends are there, nevertheless.

Looking at the 2014 Alcoholics Anonymous Membership Survey also brought some interesting information to light. This pamphlet is our most recent membership survey and one of the data tables shows the percentage of our Fellowship broken out by years of sobriety: Less than 1 year: 27%, 1-5 years: 24%, 6-10 years: 13%, 10-20 years: 14%, 20+ years: 22%.

The numbers indicate that we are losing significant numbers of members after five years of sobriety and I began to ask myself why. Clearly, we are not retaining our membership as well as we could. This may very well be a contributing factor to AA's overall lack of growth since 1990.

I was grateful for the opportunity to participate in Unity Weekend and as a result, I have an increased interest in the 2018 Communications Audit. I believe the action that we take based on that audit report may very well address what the above-referenced data shows.

challenges of protecting personal anonymity on virtual meetings and utilizing electronic payment applications. This has been accomplished through trial and error and the sharing of ideas from those who have experience. Just like in our personal recovery, we can rely on those who have come before us and have experience to share. We still have bills to pay to meet our responsibilities as sober members of society.

If your group has not set up a

method to continue your Seventh Tradition contributions, there are many options available that your group conscience can discuss.

We are also continuing to support the service structure of Alcoholics Anonymous. Although the New York General Service Office is closed, it is continuing to work to support AA through the website and email. We will hold an abbreviated General Service Conference (GSC) in late May or early June through a virtual platform. In order to prepare for the GSC, our DCM Pre-Conference meeting will be held through a virtual platform on Saturday, April 4th. As of this date, the Area 16 General Service Office Committee plans to host our Area Assembly in Macon May 15-17, 2020. We are monitoring the situation closely and will keep you informed of any changes to the Area Assembly.

The General Service Board announced the cancellation of the 2020 International Convention with heavy hearts. Due to the size and scale of the International Convention, contracts and other logistical considerations had to be addressed in a timely manner. The decision was based on the facts available at present and a sense of responsibility and care for the health and safety of all attendees and the citizens of Detroit. We call all look forward to the 2025 International Convention in Vancouver, British Columbia!

Alcoholics Anonymous is not a meeting place or a single event, it exists in all of us. It is the language of the heart and the desire to help one another. We continue to focus on our primary purpose of reaching out to those who are still suffering. I am in awe of our fellowship in Area 16 and am comforted by the fact that AA always finds a way. It's in times like these that we truly learn to live, love, and give again.

Stay healthy and we will see you soon as we "trudge the Road of Happy Destiny. May God bless you and keep you until then."
