### **Preparing for Conference**

Each spring brings our annual General Service Conference. When this Message article comes out I will be returning from the 64<sup>th</sup> General Service Conference and preparing my report for the May Assembly. I am still amazed at the vision Bill W. had to turn the fellowship over to itself.

In 1950, on the heels of accepting the Traditions at the International Convention, Bill W. proposed the General Service Conference. The idea was to have the conference for 4 years to see if the conference would work. In the AA Service Manual on pages 11 & 12, there are articles on the "Birth of the Conference" and "Delegates to Question." Within the articles Bill states, "The group conscience could safely act as the sole authority and sure guide for Alcoholics Anonymous," and "As I watched all the growth. I became entirely sure that Alcoholics Anonymous was at last safe—even from me."

In 1951 at the Southeastern Conference held in Atlanta, Bill W. was in

attendance. Bill met with the leaders of AA in Georgia, and our first delegate, Neely D., was elected to serve beginning in 1952. Georgia was designated as Area 16, and we began our journey as part of AA as a whole.

I share this information with you as I have been preparing for my first Conference. I received all of the background material mid-February. I was excited and scared at the same time. All of the fear and insecurity which I had been concerned about came true. I tried to hide my feelings at first. I am grateful I have been around long enough to have a spiritual toolbox to turn to when fear and insecurity arise. I called my sponsor and other past delegates. They all told me the same thing and gave suggestions for me to follow. The suggestions are the same anytime I get into to this spot: spend more time in prayer and meditation, attend my home group, limit additional commitments, eat right and get plenty of

rest. I began to implement the suggestions in my life. It amazes me still today that I forget the simple ideas which keep me into today.

I have been blessed to have had questions from DCMs regarding the background material and have met with a couple of them to go over the background material for a couple of the committees. Mid-April we had the DCM preconference meeting where the DCMs share the voice of the Area. I will take this information to the Conference.

This process has made me appreciate the long form of Tradition Twelve: "And finally, we of Alcoholic Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all."

- Have you ever read an article in the Grapevine or La Vina and wished you had seen it in a doctor's office, hospital waiting area, mental health ward, treatment center, or a jail/ prison when you were still "out there" working on your story?
- Which one do you think a person with a drinking problem might possibly be more likely to pick up and read in a public setting: an AA pamphlet or an issue of the Grapevine?
- How many folks might we reach with the "friendly face" look of these magazines as opposed to only our standard AA literature?

 How can our committees work together, as we all have the common goal of carrying the message to the alcoholic who still suffers?

So, folks, as I am sure you will hear from Willie, PI/CPC and Grapevine are going to be a part of a Treatment workshop in Albany on June 14! Here are a few things we will be talking about:

How can my group use the Grapevine/La Vina to carry the message outside of AA?

- Subscribe to the GV/LV, and place copies in doctor's offices or hospital waiting areas
- Consider purchasing bundles of back issues of GV to give to treatment, corrections, or PI/ CPC

- Visit doctor's offices to offer a free issue (so they can see it), along with a subscription form in case they want to subscribe. Offer yourself as a contact person if you feel comfortable doing so.
- Give copies of the GV/LV to members who take meetings into jails and treatment centers.
- Consider leaving some copies with local homeless shelters, at social services agency waiting areas such as DFACs or Mental Health.

I have even heard stories of leaving copies "accidentally" on public transit buses or trains. :)

What other ways can you come up with to use these powerful little tools of recovery to reach others?

Presently, we need AA Volunteers who are willing to get certified and take the AA message into Georgia Prisons. This is especially true in South Georgia where there are many prisons needing Alcoholics Anonymous and not enough volunteers.

"Our chief responsibility to the newcomer is an adequate presentation of the program." As Bill Sees It, p. 105. It is true that we may be the only copy of the Big Book that some of these inmates ever see. Every week, we show up for the prison meeting. These inmates know that we are giving up our personal time to be with them, so that they can have a meeting. They know that we have something special when we share our experience, strength and hope. Some of these inmates might even start thinking that they want what we have. They start working the program.

June 28

We, as AA volunteers, can only plant seeds. Where they grow is God's business. We never know which of these inmates might be the next Delegate, a convention speaker, or a Corrections Volunteer. What we do know as we walk out of the prison is that the hand of AA was there for the inmate reaching out for help. For those of you interested in carrying a message into the prisons, our next certification session is at the Georgia State Service Assembly Office in Macon starting at 8:00 a.m. on May 24, 2014. State Office, Macon – 50%, GSO – 30%, Pre-Paid Convention — 10%, District/Zone – 10%

In Atlanta, Augusta and any other District/Zone which supports a central office, we suggest that the income, after all group expenses have been paid, be allocated as follows:

Central Office – 35% State Office, Macon – 30%, GSO – 20%, Pre-Paid Convention – 10%, District/Zone – 5% or whatever percentages are in accordance with your group conscience.


