“Carrying the Message” to Corrections Facilities Through La Viña

District 17, Georgia’s Area 16 Linguistic (Spanish-speaking) District, working with Grapevine’s La Viña magazine, has implemented a program called the Chest of Hope.

The program is accepting donations of La Viña subscription certificates to be placed in a “Chest of Hope” until the conclusion of the AA National Hispanic Convention (USA and Canada) in Area 16 (Atlanta), August 30–September 1. At the conclusion of the convention, donated La Viña subscription certificates will be given out to all states and regions of the USA and

Canada. The program’s intent is to provide La Viña subscription certificates to correctional facility linguistic AA groups and thereby La Viña magazines to incarcerated alcoholics in the U.S. and Canada. This is a commendable effort by District 17 to help carry the message across the USA and Canada.

You, your group, or your District/Zone can help by purchasing La Viña subscription certificates at aagrapevine.org. Select “Carry the Message Project”. Once there, please make sure you are purchasing “Certificates” and not subscriptions. Certificates allow for “gifting” the La Viña subscriptions to unknown addressees. If you need help purchasing certificates, you can contact Grapevine at 800-631-6025. Once you receive your certificate by email, please forward it

Your Voice is Needed!

On August 31, 2018, Alcoholics Anonymous published its “Internal/External Communications Audit Report: Bringing Bill W.’s vision into the 21st century”. The General Service Board (GSB) contracted with Impact Collaborative to perform an evaluation of AA’s (GSB, Alcoholics Anonymous World Services (AAWS), and Alcoholics Anonymous Grapevine (AAGV) ability to effectively communicate with our wide variety of audiences within Alcoholics Anonymous and with key external groups, such as the professional community. The ultimate goal is to ensure AA is keeping with its primary purpose of

carrying the message to the still-suffering alcoholic.

Recommendations proposed to the General Service Board include:

- Developing more efficient and profound connectivity among AA’s three boards (GSB, AAWS, and AAGV);
- Improving effectiveness in attracting and retaining those in need of recovery, engaging the professional community, and refining public perception;
- Developing processes that strengthen and unify overall messaging;
- Employing our rich history to improve communication; and
- Utilizing social media and other interactive tools to more deeply engage the Fellowship.

We would love to hear from you! In order to provide guidance to the GSB, AAWS, and AAGV, we need your ideas. At the May Assembly in Macon, we will use the Saturday afternoon GSR workshop to host a round-robin discussion. We will divide into small groups and discuss the recommendations. Each person will have a chance to provide input on the suggestions and recommendations. We will have note-takers in each group who will document your thoughts and ideas.

During the Sunday morning Business Meeting, I will provide a summary of your ideas and recommendations to the Assembly. The coolest thing is that our Delegate, Rick M., will be in NYC at the General Service Conference so we will be able to send your ideas directly to him where he may share our recommendations!

Decrease in Contributions

Happy spring to you all in Area 16. I hope you are having a great 2019. I am having a blessed 2019 meeting so many of you at the Southeast Cluster Forum this past March. I need to go ahead now and report to you about how we are doing financially in Area 16.

As of February 28, we are a little behind budgeted expenses. Our total contributions are \$32,788.04 and our total operations expenses are \$38,743.67 for a difference of \$5,955.63. Our total literature sales in the first two months of 2019 are \$22,573.85 and our total literature expenses are \$19,221.60 for a difference of \$3,352.25. Therefore, we have a net loss of -\$2,603.38. The loss is from two sources. The first is a decrease in contributions. I reported at the January Assembly that we had a net income of \$10,142.44. Those funds went to boosting our reserve fund and

a new computer system for the GSSA office.

Please remember that we have a goal of a 12-month reserve fund, and we are currently at 11.04 months (so we are not quite there).

The second source is that most of our expenses are in the first part of the year. We are coming into a busy time of year for your Area officers and Area committees, so please help support your trusted servants.

There are things you can do to help Area 16 reach its budgetary needs. First, you can increase your group contributions to the Area. If your group is small, all we ask is that you give something to be part of the spiritual nature of the self-support principle. Second, give to our Birthday Contribution plan. This is when you give \$1 for every year you have been sober. (You also will get your name and sobriety date in the Georgia Message.) And lastly, you can just contribute to GSSA.

How Can Your Group Be Handicap Accessible?

In some districts/zone treatment and accessibilities have been separated. Treatment committees work with the treatment facilities in order to carry the AA message into the facility and make arrangements for Bridging the Gap between the facility and its home community.

Accessibilities committees work with the groups to help them become accessible to anyone wishing to attend a meeting.

We continue to get questions about groups being handicap accessible. Not all groups can be wheelchair accessible due to where they meet. However, there are other ways your group can be accessible to members that have barriers.

Does your group have a list of members willing to provide transportation to a member that does not have transportation? What about child care? Do you have a plan for single parents to bring their child (or children)?

What about the deaf alcoholic? (AA Guidelines on carrying the AA message to the deaf alcoholic) (AA Guidelines on Accessibility for all alcoholics) What about the low vision or blind member? The Big Book, the Twelve Steps and Twelve Traditions, and other literature are available in Braille.

Loners-Internationalist Meetings — What is considered LIM?

Loner - A member who lives in an area where they have no meetings available to them.

Homer - A member who is unable to attend AA meetings because of a physical incapacity.

Internationalist - A member working on a seagoing vessel for long periods of time. To find an overview of LIM history and how to be involved go to www.AA.org/assests/en-us/smf123-en.pdf

One approach is to utilize the PI/CPC pamphlets available to us depending on the types of professionals we will encounter. During our May Assembly, the PI/CPC Workshop will revolve around this topic and provide resources for you to help carry the message in this fashion. Pamphlets include the target audience of general professionals, clergy, health care professionals and corrections. The information streamlines facts about Alcoholics Anonymous as well as topics like "How to make referrals to AA," "Singleness of

Purpose," and "How it Works."

Specific topics of interest allow AA members to familiarize themselves with language that is utilized by the professional. In alignment with items being brought to our General Service Conference as well as results from our Communications Audit at GSO, it is apparent that there is a need to meet the professional at their level to present the guidelines for Alcoholics Anonymous. The four main pamphlets written to the professionals will be used as well as some scenarios and role-playing activities to put it into practical application at once.

Our friends in District 16B Athens area will be hosting our Area PI/CPC Workshop this summer in July. Fliers have been sent to the District mailboxes. The topic is "Speaking at Non-AA Meetings." Please help spread the word about this vital way the AA member can help carry the message.

This March I celebrated my 31st sobriety anniversary and contemplated my experience in AA over those years with Communications, **the sharing of information**, in mind. I thought I knew the AA program early in sobriety. After all, I was working the Steps, working with my sponsor, sponsoring others, holding service positions in my Home Group – what more could there be? **I didn't know what I didn't know.**

I was sober for many years before I learned about the 12 Concepts; that our triangle represents Unity, Service, and Recovery; that we have a wealth of information in our pamphlets; that there is more

literature available to us than just the Big Book and 12 & 12; that I can search on any topic on the www.aa.org website. These types of items were not discussed at the meetings I attended and for whatever reason, or character defects, I didn't attempt to search for more knowledge. I found that I was not unique in this respect. **We don't know what we don't know!**

We are a program of action so what is the solution to help ensure our information is being shared? I found my sobriety enriched when I took personal responsibility for my knowledge of AA. I attended workshops; studied the pamphlets and Service Manuals; did topic research on www.aa.org etc. The information available to us is voluminous.

I hope you will visit the various sources of information, including the www.aageorgia.org website, and communicate what you find, and how you found it.

Chapter 7 of the Big Book begins with "PRACTICAL EXPERIENCE shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics." So, where do you find these alcoholics? At the writing of this article, the Department of Corrections, the Department of Juvenile Justice, and local jails have almost 100,000 people behind bars. It seems that we have thousands and thousands of alcoholics behind bars — just waiting for you.

We need AA in these places so that hearts can change. As Warden Edd Sanders used to say: "97% of inmates will be released, and they

might end up on your back porch." Whether they show up to steal your stuff or to talk to their Sponsor is up to us.

We have state training coming up on May 25th for state facilities. We also support local efforts to get into local jails. Your spare change in a pink can helps to buy AA materials for those incarcerated. All this prepares incarcerated inmates for an AA meeting on their first day of freedom.

GSO recently let us know that there is a desperate need for male Corrections Correspondence volunteers. This service opportunity is available even if you just got out of prison! Contact GSSA for details.

Finally, Georgia had wonderful representation at the 31st Freedom from Bondage Conference. Dawn U. of the Meldrim Group was a panelist. Thank you, Dawn, for your service!

Our Great Responsibility

Searching and cataloging our GSSA Archives are ongoing affairs. We have discovered some interesting recordings and items that had been buried in the boxes we are searching through. As we endeavor to work our way to a conclusive end, we take solace in the fact that the same thing is ongoing in the New York GSO Archives.

New York's search has revealed a varied result of the General Service Conferences archives, one being the creation of a new book being published and available in May. The following is the introduction to "Our Great Responsibility" from the Spring edition of Box 459, which is available on the aa.org website.

During the course of 20 General Service Conferences, Bill W. gave more than 33 talks, 16 of which are now gathered in the new book "Our Great Responsibility: A Selection of Bill W.'s General Service Conference Talks, 1951–1970," which is scheduled for publication in early May 2019. Not only does "Our Great Responsibility" represent the first time these talks have been made available in print form to the general reader, but it is also the first original book from Alcoholics Anonymous in over 30 years.

"The talks included in 'Our Great Responsibility' capture a clear picture of Bill's vision for the future of AA and pose questions that are still quite relevant today," says Greg T., GSO's general manager. "They also give fresh insights into AA history and the enduring purpose of the General Service Conference."

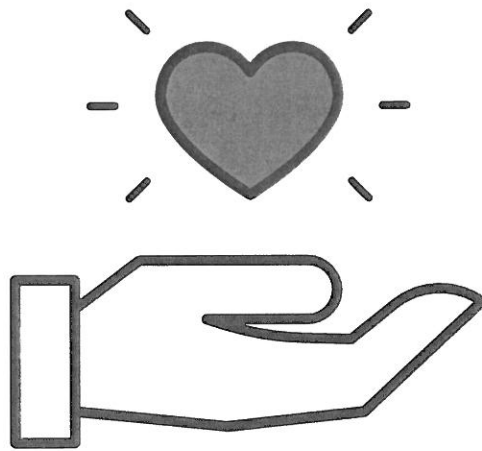

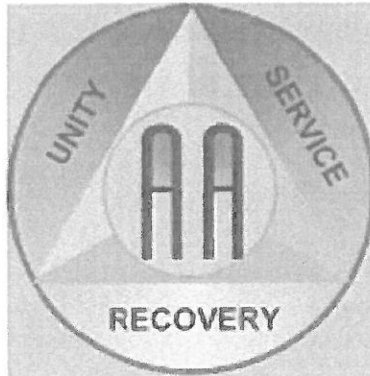
