16. If you are wondering why we use this method you will find some good reasons in the latest edition (2011-2012) of the AA Service Manual by reading Concept IX on pgs. 34-40. The voting procedure itself can be found

on pgs. S21 & S22. And a short essay on the Eligibility to Vote can be found on page S37 (In Area 16 we have a couple of slight modifications to this procedure). I encourage this reading as it reminds us about the importance of good leadership.

Have you ever noticed how the candidate receiving the most votes after Round 1 suddenly gets a lot more votes in Round 2? If you are a GSR reading this and have changed your vote after Round 1 I'd like to know why you changed. My guess would be because it is a long process and we all just want to get out of there. However, the Third Legacy process begins to eliminate candidates after the 2nd Round and we should let the process change our vote if our candidate is eliminated. In my opinion, we should stick to our candidate until the process either elects or eliminates them. Just something to think about as you read the pages I mentioned above.

As we near the end of the calendar year many groups and districts will be electing new GSRs and DCMs. Your election process will probably not take as long as elections during the September Assembly but that doesn't make them less important. We should always try and select the best candidate for the job. And that person is not necessarily the one who leaves for a bathroom break during voting!

## The year in review

As 2012 draws to a close, the Area 16 Corrections Committee continues to carry the AA message of recovery to the alcoholics who still suffer in Georgia's correctional facilities. Let's take a quick look at where we stand as of the end of September, by the numbers:

- 458 copies of AA conference approved books have been supplied to our state's inmates in correctional facilities by the Area 16 Coins for Cons Program. This includes the 200 Big

Books that were delivered to the West Central Integrated Treatment Facility in Zebulon in March.

- 269 Bridge The Gap forms were received from inmates looking to transition from AA on the inside to AA on the outside. This is a wonderful program which provides pre-release contacts for our inside members as they re-enter society.
- 93 AA volunteers received training for certification at our three training sessions at the state office in Macon this year. These are offered free of charge to AA members interested in entering any Georgia Department of Corrections facilities.
- 21 of the 33 state prisons now have

AA meetings established, with seven more requesting our assistance. We will continue to extend the hand of AA to our alcoholic inmates as we move forward from here.

None of this would have been possible if it wasn't for the participation by our AA Corrections volunteers all over Georgia. Whether you donated to the Coins For Cons Program, helped out with Bridge The Gap, or carried the message into our state's jails and prisons, we are extremely grateful for your efforts!

We hope that everyone enjoys a safe and happy Holiday season and we look forward to seeing everyone at the January Assembly.

## Suggestion for Thanksgiving

In 1949 Bill wrote the Grapevine article "A Suggestion for Thanksgiving". The first thing that popped into my head was "Gratitude". But that was not his suggestion. It was to "adopt Thanksgiving week as a time for meetings and meditation on the Traditions of Alcoholics Anonymous".

Bill started the discussion of the Traditions in an article written for the Grapevine in April, 1946. By that time, Alcoholics were staying sober, and

the question now was the unity of Alcoholics Anonymous: "how to preserve among us AAs such a powerful unity that neither weakness of persons nor the strain and strife of these troubled times can harm our common cause. We know that Alcoholics Anonymous must continue to live. Else, save few exceptions, we and our fellow alcoholics throughout the world will surely resume the hopeless journey to oblivion."

From "A Suggestion for Thanksgiving", Bill writes, "The Twelve Traditions of Alcoholics Anonymous are a distillate of our experience of living and working together. They apply the spirit of the Twelve recovery Steps to our

group life and security. They deal with our relations with the world outside and with each other; they state our attitudes toward power and prestige, toward property and money. They would save us from tempting alliances and major controversies; they would elevate principles far above personal ambitions. And as a token of this last, they request that we maintain personal anonymity before the open public as a protection to AA and as proof of the fact that our Society intends to practice true humility."

I have immense gratitude for the Twelve Traditions. They, like the Steps, have helped save my life.

State Office, Macon – 50%  
GSO – 30%  
Pre-Paid Convention – 10%  
District/Zone – 10%

In Atlanta, Augusta and any other District/Zone which supports a central office, we suggest that the income, after all group expenses have been paid, be allocated as follows:  
Central Office – 35%  
State Office, Macon – 30%  
GSO – 20%  
Pre-Paid Convention – 10%  
District/Zone – 5%  
or whatever percentages are in accordance with your group conscience.

That document has been posted on our website [www.aageorgia.org](http://www.aageorgia.org). It can be found under the 'service' tab on the home page and then under 'reports.'

GSO has asked for fellowship feedback on our latest membership survey and on the effectiveness of the short form of Tradition 11th. Both of these items will be posted on our website very soon. Please participate in providing feedback. Another item I want to encourage you all to participate in is the Birthday Plan. In the Birthday Plan we are encouraged to send in one dollar for every year sober to the service entity of our choosing. On or around my A.A. birthday I send a check to three different service entities – GSSA, GSO, and my local Intergroup. I love the idea of this self-support concept because I get to decide how to show my financial gratitude and I can make sure my home group gets credit for my contribution by simply adding my home group service number to my check. So, for all those groups, like my home group, who struggle to pay the rent, make coffee, and send in a little money to support AA I can directly increase my home groups contribution to the service structure using the Birthday Plan. I'd like to ask all GSRs and DCMs to encourage members to use this wonderful self-support tool.

There is an update on the eBook Project. Recently AAWS conducted an intensive review of the work on the eBook Project. One of the conclusions was that creating and maintaining AAWS eReader Apps was not sustainable in the long run. AAWS has encountered changes in technology, extensive development time, and high support costs in order to maintain these

apps.

Following much thoughtful discussion of the review, the conclusion was that continued development of eReader Apps is not a practical or prudent use of GSO resources. Rather than committing more resources to this effort it was decided to end production of an Android eReader App.

For the time being, we will maintain what we have created with resources already committed. Along these lines, an update to the Apple iPhone App will be released as soon as possible, and we will continue to provide support for this App.

Moving ahead, AAWS has decided that the best way to make eBooks widely and easily available is to utilize eReader vendors to sell our eBooks. We will begin working toward implementation of this distribution process, with a planned release of AAWS eBooks following the 2013 General Service Conference.

This new plan will be forwarded to the Conference for approval prior to implementation. It is my belief that we as a fellowship sometimes place demands on AAWS that do not pass Bill W's suggested method of using the spiritual and practical test. In other words, it may have sounded spiritual to build our own app and thereby avoiding affiliation tradition violations but it was not a practical idea. Before we make changes in AA we should make sure ideas pass both the spiritual and practical test. The cost of creating an app and supporting it is not in line with our Primary Purpose and in my opinion is being wasteful with AA's money. It makes so much more sense, and passes the spiritual and practical test, to hire a vendor to create, update, and support an eReader app while we tend to helping alcoholics find and maintain sobriety. And to link our affiliation to any such vendor as a Tradition Six violation would be like saying GSSA is affiliated to Marriott because we hold our Assemblies in this facility. I hope we stop making such affiliation comparisons just because we hire a vendor to perform services for us.

This year the General Service Conference supported the idea for the General Service Board to develop a plan to restructure AAWS and AAGV. The trustees' Planning Meetings on Structure have been positive in leading to a deeper understanding of the problems. The focus has been on defining more precisely the structural and communication problems that need to be addressed. This plan is still being developed and will be presented to the 63rd

GSC. I just wanted to keep you posted on its progress.

I wanted to talk with you this morning about AA's 100th birthday. AA will turn 100 years old in the year 2035 – a short 23 years from now. The planning for the 2015 International Convention in Atlanta began in 2003. GSO begins planning for the International Conventions 12 years in advance. I don't believe this is enough time to plan for AA's centennial event. AA is not just held in high regard within its own fellowship, and this is reflected in the Library of Congress' recent proclamation of listing the Big Book as one of 88 books that shaped America's history. Think about that statement. The book that we study to find and maintain sobriety has been listed as one of 88 books written that shaped America's history. Stepping Stones, the home of Bill and Lois Wilson, will most likely soon be listed as a National Historical Site. Bill W. was named man of the year by Time magazine. Our hundredth birthday should be a yearlong celebration just like many other centennial celebrations. I have discussed this idea for several years and was able to pose the idea of early planning for this event at this year's GSC. I simply asked if there was a committee formed to look into this event and the answer I received was no. I was then asked to forward a proposal to the General Manager and the trustees Committee on International Conventions and Regional Forums. I want to send this proposal forward with the backing of Area 16. You will see this item under new business and the motion I hope you approve during the business meeting is as follows;

"We of Area 16, Georgia, recommend that the General Service Conference form a committee in 2013 to begin the planning for AA's 100th birthday in 2035. We feel this event is significant in our history and requires an extended planning period to consider an appropriate celebration."

Lastly, The Final Conference Reports are in the back of the room. Please take only one report per group. Before I close I want to take a minute to highlight a few items in that report.

- On page 6 you will find the GSC theme and presentation topics that we will adopt as our own in the business meeting this morning. Also on page 6 and on page 7 are the inventory questions that will be used over the next three years for the conference inventory. You may find some of these questions apply to your own group or district inventories.

- On the next few pages you will

find all of the Advisory Actions for the various conference committees.

- All of the presentations can be found on pages 10 thru 17.
- Beginning on page 20 you will find reports from the General Service Boards, AAWS, and GV Corporate Boards.
- On page 47 you will find the most important part of the Final Conference Report. That is my Area 16 highlight!
- Beginning on page 61 you will see financial reports. Now turn to page 70, look down to line 16, then across to the 4th column. That 65.5 number is the percentage of groups in our Area that send in contributions. We have the highest percentage of groups contributing in the United States! I thank you for that. Now scroll down to lines 87 thru 90 and then over to column four and you will see a few Areas in Quebec that have a higher percentage of groups contributing. I think we can beat them if we educate our members about the birthday plan! Also, at the bottom of page 71 you will see an overall decrease of 1.5% from 2010 to 2011 in group contributions. We really need to reverse that trend and I am asking for your help with this. Total operating expenses for the General Service Office were about \$13.5 million for 2011. Imagine trying to raise that amount of money one dollar at a time or from loose change in a basket? Please be as generous as you are able in financially supporting AA.

- Lastly, on pages 75 and 76 you will find a little information about our Class A and Class B trustees.

I wanted to get you to open up the Final Conference Report this morning and look through it a little bit with me in hopes it would make this information less intimidating. Perhaps in the same way going through the Big Book with someone makes it more valuable to them than just handing them the Big Book in hopes they will read it. There may be parts of the Final Conference Report that are more appealing to you than other parts. Page 47 for example. This is not a report that I will typically read cover to cover. I read it sections at a time and I hope you will as well. This concludes my report and I will now take questions.

### Treasurer Report – Don M.

As you can see on page 70/71 of the General Service Conference Final Report, Area 16 (Georgia) has the highest percentage of groups contributing to the General Service Conference. Congratulations! However, we are not fully self-supporting in our Area, as we are \$6,000 behind in contributions thus far this year. We are also \$1000 behind in Prepaid Convention contributions for the year. Please take this back to your groups and see what we can do. Don read the "Green Card" and the baskets were passed.

### Old Business:

1. Approval of minutes from the May 20, 2012 business meeting as printed in the July/August 2012 Message. Motion to accept by Sam C., and 2nd by John R., Twilight Group. Motion unanimously passed.
2. Committee on "We Share" - In January the Assembly voted to update the "We Share" book, the History of GA AA. Claudia S., our Archivist reported for the committee. Three (3) persons have been assigned to coordinate history within GA - Bill F. - Atlanta Area to include Districts 13A-K, 16A-F, and 17; Shari M.-East Coast Area to include Districts 3A-D, 4, 5A-D, 8, 9, 11A-C and 12A-B; Mandy E. - West Coast Area to include Districts 1A-B, 2A-B, 6, 7A-B, 10A-E, 14A-D and 15A-B. Committee will keep original information and retype in digital format for editing and adding new district/group information. The original book is available on line under the Archives Section on our Website for your review. Also available is a digital group information form which will ask questions about group, i.e. when started, who started, how long lasted, etc. This form is for group history or to update current information. The deadline for submitting information for the book is September 2013. Please submit your information as soon as you have it ready. The committee is planning on having the "WE SHARE II" book ready and printed in time for the 2015 International Convention.

### 3. Report from Ad Hoc Committee Treatment/Accessibilities

In January the motion was made to change Area 16 Service Manual to change the Treatment Committee name to add "Special Needs Accessibilities" to read Treatment/Special Needs Accessibilities Committee to be consistent with the General Service Conference committee. It was tabled and an Ad Hoc committee was appointed to bring back the feasibility of combining the two functions within Area 16. The committee was not able

to do so in May so report was tabled until September Assembly. Rick M., Alt DCM, 13A, Chairperson, presented committee report to the Assembly. Discussion followed report and wording change was proposed during discussion from floor.

Friendly motion made by Tom, GSR, Third Tradition Group, seconded by Damon, Breakfast Club Group to change wording. No vote was necessary as the Ad Hoc Committee readily revised its wording in the last sentence pertaining to change on Page 21 of the Service Manual from "providing advice" to "providing guidance" on Special Needs Accessibilities and the treatment facilities in their districts. Entire report is printed here and will be sent to the District Mailboxes and will also be available on the website under reports section. The Manual Change will be voted on at the January 2013 Service Assembly.

### Report:

The following members make up the committee – Gina B. DCM 7A, Fran M. Alt DCM 12A, Clint C. Alt DCM 14C, Willie S. Co-Chair Treatment Committee, and Jimmy S. Chair Treatment Committee.

Our assignment: To research adding Special Needs Accessibilities service committee to Area Treatment committee and change the name and description in the Area Manual. The name would be consistent with the General Service Conference committee Treatment/Special Needs Accessibilities. Additionally, we were asked to study the feasibility of adding Special Needs Accessibilities to Treatment. Look into the responsibilities and qualifications of the committee chair and any changes that may be necessary and then, if we are in support of this change, make recommendations. Our report should also include that our Treatment committee had taken on this function already to verify the feasibility of combining the two functions within Area 16. It has been more than two years and they feel it is no problem.

### Recommendations:

We have reviewed all available documentation including the Area 16 Service Manual, met with the Treatment Chair and co-Chair, met and discussed as a committee, and have concluded this is a good move to combine the two service functions and change the name and description to Treatment/Special Needs Accessibilities. The following Area 16 Service Manual changes are recommended:  
Page 20: Change Description (Title)

from "TREATMENT COMMITTEE CHAIRPERSON" to "TREATMENT/SPECIAL NEEDS ACCESSIBILITIES CHAIRPERSON"  
Page 20: Add a new duty: "2. Become thoroughly familiar with Special Needs Accessibilities topics and the Special Needs Accessibilities Workbook."  
Pages 20-21: Re-number list of Duties/Qualifications and add #9 to list.  
Page 21: Modify existing #6 qualification from "Should be able to organize and lead particularly in his/her contacts with DCMs and GSRs, and the treatment facilities in their districts." To "Should be able to organize and lead particularly in his/her contacts with DCMs and GSRs, by providing guidance on Special Needs Accessibilities and the treatment facilities in their districts."

### New Business:

1. Motion to approve the 2013 Conference Theme: "The General Service Conference Takes It's Inventory - Our Solution in Action." Motion to accept by Amy S., Serenity by the River Group. Seconded by Ed., New Beginnings Group, Macon. Unanimously approved.
2. As Tom had spoken about in his report to the Assembly, a Motion was made by Amy S., Serenity by the River Group, and seconded by Brit S., Abbeyville Group, 2B. Motion reads: "We of Area 16, Georgia, recommend that the GSC form a committee in 2015 to begin the planning for AA's 100th birthday in 2035. We feel this event is significant in our history and requires an extended planning period to consider an appropriate celebration."
