Finally, he sorted the mail out to the desk that would normally handle those letters. Almost daily he would then deliver the letters to the appropriate staff member. Talk about going to any lengths for Alcoholics Anonymous!

While our General Service Office staff are paid employees, they are also alcoholics that love our Fellowship and are passionate in their work for us. I saw firsthand their excitement and joy when we were the first tour of the office since April of 2020.

Every letter sent receives a response. Every phone call is answered

What is the Georgia State Service Assembly? The Georgia AA Service Manual states, "The Georgia State Service Assembly is the combined effort of every AA group in the state, through the groups' elected GSR to resolve all issues affecting Georgia AA as a whole, and to send the elected Delegate from this Assembly to the General Service Conference to resolve all issues affecting AA as a whole." The Assembly Format can be found on page 14 of The Georgia AA Service Manual. There are four guidelines describing the format, when, and location of the Assembly.

Our Assembly is a full weekend of meetings and workshops. There is a Friday night open discussion meeting hosted by one of the local AA groups. Saturday morning has several different workshops, depending on the service position you hold and what piques your interest. If you are new to the Assembly, the workshop Assembly 101 helps you get the most out of the Assembly. Each Area 16 Service Committee holds a workshop to help Districts and groups with ideas and resources. There is also a Secretary/ Treasurer workshop facilitated by the Area 16 Secretary and Treasurer to guide and instruct how these positions operate at the District and group level. In the afternoon a DCM meeting is held with the Delegate and Office Committee to discuss what will be presented at the Sunday morning business meeting and any other pertinent information. GSRs can attend an informative orientation on what it means to be a GSR. In the late afternoon the GSR workshop is filled with presentations, Service Committee reports, and an Ask-it-Basket. Saturday night we have an open speaker

Finance Update By Kelly G. Area 16 Treasurer

It was an honor to be present with y'all in Dublin this last month. As you know, my first year as Treasurer was fully virtual, and I was not able to make the first Assembly of 2022. It made such a big difference to be able to be there with all of you and hear all the great things you're doing in your groups and Districts. I want to thank all of you who joined the Secretary & Treasurer workshop on Saturday. It was our best participation yet!

Our finances for 2022, thus far, are strong. Our ordinary income was \$94,373, which is \$6,889 more than we budgeted. Our literature income was \$24,987, which is \$2,847 less than budgeted. However, we netted \$4,042 more in overall income than we budgeted for. Our overall expenses were \$78,729, which is \$11,765

less than we had budgeted. Please note that facility restrictions are still affecting many of our committee's ability to travel. We expect to see these figures increase over time.

With a total income of \$94,272 and total expenses of \$78,729, GSSA netted \$15,645 for the first four months of the year. I would like to thank our groups and Districts in Area 16 for continuing to support the efforts and service work of our Area. Your commitment funds the services to help the still sick and suffering alcoholics in Georgia.

I am looking forward to working with the Budget and Finance Committee over the next few months to present a budget for the 2023 year. Be on the lookout for information from your DCMs in the coming months. Again, thank you for this opportunity to serve. I am excited to continue working with all of you.

Continuing the Work of Our Founders

Our founders focused on carrying the message to other alcoholics inside treatment centers. They found that their prospects were more receptive when approached in this way. Today, AA has become a household name, and many prospects search out a local meeting, but many others have misconceptions about our program of recovery. The Treatment side of our committee works with District and group treatment representatives to carry the AA message into facilities. If you are involved in taking the message into a facility or would like to become involved, we are here to help. Come to our Assembly workshop or reach out to us through the Area website.

Although many facilities are still limiting visitors, we can make initial contact with newly recovering alcoholics through the Bridging the Gap program. The Bridging the Gap program allows treatment facility patients to request an AA contact in the Area they will live when they leave the facility. The request is forwarded to our committee, and we reach out to a local AA member to make initial contact with the patient and offer help getting to a meeting within 24 hours after the patient is released. If you are in contact with a facility and want to talk with them about the Bridging the Gap program, let us know.

Can every member or prospective member in your District attend a meeting? The Accessibilities side of our committee works with Districts and groups to make sure that a meeting is accessible to all who want to attend. Barriers can include physical access to the space, as well as language, transportation, or childcare issues.

Are we making sure that AA is accessible to all who need it? Are there barriers that keep members or potential members from attending our meetings? We are available to help make our society accessible to those who may have health, language, age, or caregiving issues.

We look forward to seeing everyone at the September Assembly!

Does my Group or District
Need a Communications Chair?

- Maintain current meeting schedule printed copies, update group information on GSSA site
- Communicate/notify/remind members of upcoming business meetings
- Attend District/Area Assemblies to assist GSR with sharing information
- Assist group with translation/ acquiring materials in Spanish/braille, etc. if needed

Every group is autonomous in the way it functions, and it therefore can create/ use a Communications Rep as it best serves its needs. That is the beauty of our AA Traditions.

If you are a GSR that attends Assembly, I encourage you to reach out to other groups in your Area that may not be as active. Our hope is to increase the voice of the groups in Area 16. Our DCMs are working hard to reach out in their Districts. When we work together, we provide an opportunity for alcoholics to participate in their own recovery and pass it on to the newcomer.

Finally, there is a spiritual reason for the "Right of participation" (Concept IV). All of us desire to belong. In AA, no members are second class, therefore no member is placed in ultimate authority over another. We perform tasks better when we are sure we belong — when our participation assures us that we are truly the "trusted servants" described in Tradition Two. We are blessed beyond measure!
